### Call for Artist update

Ms. Cousins reported she has not received any responses. She is going to reach out to Karen Acres at the Workhouse Arts Center in Lorton.

### **Community Center Indoor Mural update**

- -Mr. Cheselka reported he, Ms. Blevins, Nicole Falceto and Deborah Kennedy met on June 17 to discuss design options and next steps. A large colorful tree which was presented was the decided choice. Nicole will present the image to Leslie Herman. Need to find out if the image presented is copyrighted. Ms. Cousins made a motion to accept the rendering of the tree mural with the modification of no lights to be presented to Council at the July 8 work session. Ms. Carlini seconded the motion. The motion passed unanimously.
- -The second design was a colorful rendering of Town of Vienna iconic images. Ms. Kang made a motion to accept the TOV rendering to be utilized for future VPAC projects. Ms. Cousins seconded the motion. The motion passed unanimously.
- -The third design was a random sidewalk scene. This image was not accepted.

#### Citi-Bank mural update

-Mr. Cheselka reported there has been no response for the Call for Artist for the Citi Bank mural project. Citi Bank wants to consult with their own art department, and do the mural themselves, with possible guidance from the VPAC. Their timeline for completion is August/September 2024.

-Ms. Dehn reported she is prepared to print 20 shirts this week. She will upload the PDF design on the VPAC shared google drive. Ms. Carlini made a motion to accept the shirt design and

approval to move forward with printing. Ms. Kang seconded the motion. The motion passed unanimously. Ms. Dehn will provide the invoice for the shirts to Mr. Cheselka for payment.
