
PUBLIC NOTIFICATION AFFIDAVIT

A sign was posted in front of Town Hall on **April 22, 2026**, with the public hearing date for Town Council’s hearing. A photo of the posted sign is attached.



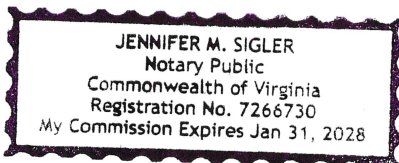
