the property:

The property interest was acquired in good faith, and the hardship for which relief is sought was not created by the applicant. The hardship results from the property's unique location and natural

plant landscape. The hardship is directly attributable to the unique factors: physical conditions of the property, specifically its location adjacent to the floodplain and the high groundwater table. The proposed fence is a solution that addresses these hardships. contributes positively to the environmental health of the area, and aligns with the Town's commitment to responsible land use.

Proximity to Floodplain: The property is situated near FEMA's Zone AE floodplain, with the lowest point on Follin Lane next to Wildwood Park and Wolftrap Creek at the end of the slope. This characteristic existed at the time of property acquisition and creates challenges for stormwater management and landscaping protection.

High Groundwater Table: The soils on the property, Beltsville Complex and Hatboro-Codorus, have a high groundwater table. This physical condition existed before current ownership and contributed to persistent puddling in the back yard and along the rear fence line. (According to NVSWCD Soil Assessment letter for VCAP Project)

These conditions are inherent to the property's location and topography and were not created by any action.

Describe how condition or situation is unique to your property:

Existing Conditions, Drainage, and Erosion Problems

Property backyard slopes towards the Wolftrap Creek floodplain and Wildwood Park. This slope, combined with the high groundwater table, leads to consistent puddling in the backyard especially near the rear fence line, presenting drainage and erosion challenges. The existing rear downspouts currently exacerbate this by channeling rainwater down the slope towards the park.
