A RESOLUTION FOR THE <i>BOARD/COUNCIL</i> OF THE <i>COUNTY/CITY/TOWN</i> OF
VIENNA, VIRGINIA AS AN ENDORSEMENT OF <u>Mashie Drive SE Sidewalk</u> PROJECT
WHEREAS, in accordance with the Commonwealth Transportation Board construction allocation procedures, it is necessary that a resolution be received from the sponsoring local jurisdiction or agency requesting the Virginia Department of Transportation (VDOT) to establish a project in the <i>County/City/Town</i> of <u>Vienna</u> .
NOW, THEREFORE, BE IT RESOLVED, that the <i>County/City/Town</i> of <u>Vienna</u> requests the Commonwealth Transportation Board to establish a project for the construction of <u>Mashie Drive SE Sidewalk</u> project.
BE IT FURTHER RESOLVED THAT: The <i>County/City/Town</i> of <u>Vienna</u> hereby agrees to provide its share of the total cost for preliminary engineering, right-of-way and construction of this project in accordance with the project financial documents subject to appropriation.
BE IT FURTHER RESOLVED THAT: The <i>County/City/Town</i> of <u>Vienna</u> hereby agrees to enter into a project administration agreement with VDOT and provide the necessary oversight to ensure the project is developed in accordance with all applicable federal, state and local requirements for design, right-of-way acquisition, and construction of the project.
NOTE: The following section is applicable only to municipalities that maintain their roads, and to Arlington and Henrico counties – Do not include for all other localities: BE IT FURTHER RESOLVED THAT: The County/City/Town of Vienna will be responsible for maintenance and operating costs of the facility as constructed unless other arrangements have been made with VDOT.
BE IT FURTHER RESOLVED THAT: If the <i>County/City/Town</i> of Vienna subsequently elects to cancel the project, the <i>County/City/Town</i> of Vienna hereby agrees to reimburse VDOT for the total amount of costs expended by VDOT through the date VDOT is notified of such cancellation. The <i>County/City/Town</i> of Vienna also agrees to repay any funds previously reimbursed that are later deemed ineligible by the Federal Highway

BE IT FURTHER RESOLVED THAT: The *Board/Council* of the *County/City/Town* of <u>Vienna</u> hereby grants authority for the *County/City/Town Administrator/Manager* to apply for funds and
