Dear Mr. Gallagher:

We are pleased to have this opportunity to provide professional services on the referenced project. Upon verbal or written authorization to proceed with performance of the services described herein, this proposal, along with all attachments hereto, will constitute a binding agreement ("Agreement") between Urban, Ltd. ("Urban") and the Town of Vienna ("Client").

It is our understanding of the Project that it will consist of survey work as discussed with Client regarding sidewalk on Courthouse Road. Survey will be on both sides of the segment. Arborist evaluation on the entire western side of the segment and engineering design in Phase 1 west side only.

This proposal and the scope of services and fees described herein are based upon codes, ordinances, and regulations of the Town of Vienna and the Commonwealth of Virginia in effect of the date of this proposal. Modifications to Client requirements or to codes and regulations that would require additional services to be performed will be invoiced on an hourly rate basis in accordance with Rate Schedule attached hereto, or, alternatively, in accordance with a change order that will specify the additional services and the associated additional fees.

Urban's fees for Basic Services for each phase are described herein with a summary below:

Base fee for the tasks \$47,800.00 Budget estimate for reprographics and reimbursable expenses: \$200.00 Total fee for contract, up to: \$48,000.00

SECTION 1 – SCOPE OF SERVICES AND FEES

The scope of services ("Scope") and associated fees shall be as follows:

Task 1 – Survey of Existing Conditions – Phase 1 and 2

Urban shall establish horizontal and vertical survey control and survey both sides of the street in the approximately 810' segment indicated by the Town during scoping to and including the intersections for purposes of preparing an existing conditions base for use in the construction plan. Survey corridor shall be 35+' on west side, and 10'+ on east side as discussed in the scoping meeting within both the Phase 1 and Phase 2 areas. This task includes the as-built of storm drainage from the survey limits, establishing property lines for lots and right-of-way in the survey limits, topography, surface features, utility marking survey, drafting and field walk by a survey manager.

Fee: \$7,900.00, Hourly Rate Not to Exceed without Client authorization

<u>Task 2 – Private Utilities – Courthouse Road SW</u>

Urban shall subcontract a utility firm to paint locations of utilities in the survey limits. Urban shall survey the markings and incorporate into the existing conditions base.

Fee: \$5,800.00, Hourly Rate Not to Exceed without Client authorization (includes sub-contractor fee and Urban's fee to locate)

Task 3 – Arborist Tree Assessment – Phase 1 and 2

Urban's ISA certified arborist will make one site visit to review existing trees along the west side only the street segment from Maple to Locust and will provide in a memorandum report a preliminary assessment as to the health/condition and potential general construction impacts to the existing trees in or immediately adjoining the street right of way/proposed sidewalk construction area.

Fee: \$2,000.00, Hourly Rate Not to Exceed without Client authorization

Task 4 – Construction Plan 30% - Phase 1

Urban shall prepare a construction plan for the installation of curb and sidewalk improvements along one side of Courthouse Road SW totaling approximately 470 linear feet. Improvements and scope assumptions are as follows:

- 1. Coordination with active development plans on the adjacent properties.
- 2. Existing curb and gutter to remain.
- 3. Sidewalk, one side, along the segment.
- 4. New driveway entrances design when existing entrance conflicts with sidewalk
- 5. Pavement plan for patch/new pavement as applicable.
- 6. New CG-12 designs at intersections.
- 7. Plan will include general notes, typical section, demo plan, erosion and sediment control plan and narrative, grading plan, details, and other items necessary for construction.
- 8. Plan will provide VRRM spreadsheet for the water quality requirement for purposes of purchasing water quality credits.



- 9. Plan assumes limited storm evaluation and assumes no storm replacements or design required.
- 10. See Section 2 for Exclusions

Fee: \$4,900.00, Hourly Rate Not to Exceed without Client authorization

Task 5 – Construction Plan 95% - Phase 1

Urban shall respond to Town comments to the 30% set and complete the design to the 95% level.

Fee: \$9,500.00, Hourly Rate Not to Exceed without Client authorization

Task 6 – Construction Plan 100% - Phase 1

Urban shall respond to Town comments on the 95% set and complete design to the 100% level.

Fee: \$2,000.00, Hourly Rate Not to Exceed without Client authorization

<u>Task 7 – Construction Cost Estimate – Phase 1</u>

Urban shall prepare a cost estimate for the project utilizing unit price lists for the proposed improvements for the Town's use in budget preparation.

Fee: \$2,700.00, Hourly Rate Not to Exceed without Client authorization

Task 8 – Easement Plats or Right of Entry Exhibits

Urban shall prepare easement plats if required. Fee includes plat preparation and processing through approval. Client shall be responsible for Deed preparation and any submission fees. If Town uses Right of Entry agreements instead, then this task will be used for the ROE agreement exhibits.

Fee: \$3,500.00, Hourly Rate Not to Exceed without Client authorization

Task 9 – Meetings, Coordination, Exhibits and Special Studies

Urban shall coordinate with the Town and other stakeholders as required, and typical meetings and coordination as may be required. Meeting with Town for scoping and preliminary work. Service also includes coordination with Contractor and responses to various RFI's. Service also includes support services to Client, if necessary, for private utility coordination. Service includes various exhibits as requested. Service may include other ancillary items as may be requested by the Town carry over from other tasks previously exhausted. Services performed under this task may also include any miscellaneous related work if requested by Client and not applicable under any other task.

Fee: \$7,500.00, Hourly Rate Not to Exceed without Client authorization

<u>Task 10 – Title Work – Commercial Properties</u>
Urban shall use a sub consultant to procure title work so as to provide accurate information on the commercial properties. Fee is assumed cost, actual will be invoiced.

Fee: \$2,000.00, Hourly Rate Not to Exceed without Client authorization



SECTION 2 – EXCLUSIONS

The Scope of Services is generally limited to those items listed above and specifically excludes the following:

- 1. Landscape Plan and computations
- 2. Tree Preservation Plan
- 3. Detailed hardscape design (benches, monuments, etc.)
- 4. Maintenance of Traffic Plan
- 5. Design of sight light improvements or photometrics and Electrical engineering design of lighting circuits
- 6. Private utility easement plats or vacation plats
- 7. Federal, State, and/or local permits other than any of those described herein
- 8. Revisions to work caused by Ordinance changes and/or Client requested changes
- 9. Any field surveying not covered in Task descriptions
- 10. Construction stakeout
- 11. Wetlands consulting
- 12. Environmental and historical resources consulting
- 13. Geotechnical investigation and/or design
- 14. Structural engineering design
- 15. Construction and contract administration
- 16. Specification Package
- 17. Storm drainage or stormwater management design



<u>SECTION 3 – REIMBURSABLE EXPENSES</u>

"Reimbursable Expenses" shall include actual expenditures made by Urban or its subconsultants in the interest of the Project and will be billed at the actual cost to Urban plus five percent (5%) for handling and indirect costs. Reimbursable Expenses shall include, without limitation, costs of items such as the following:

- 1. Messenger service, special mailing, long distance telephone calls and fax charges
- 2. Submission fees
- 3. Fees and expenses of special consultants
- 4. Rental of special equipment
- 5. Local auto travel
- 6. Delivery charges for samples, field testing equipment, etc.

Fee: Budget Estimate \$100.00

<u>SECTION 4 – REPROGRAPHIC CHARGES</u>

"Reprographic Charges" will be billed in accordance with Schedule "A". It is anticipated that the majority of submissions will be done electronically.

Fee: Budget Estimate \$100.00

SECTION 5 – FEES FOR SERVICE

- a. Urban's fees for Basic Service for each Phase are described herein. The total fee for the contract is up to \$47,800.00 plus reimbursable and reprographic expenses, which have been budgeted herein at \$200.00. Urban's fees for Additional Services shall be billed on an hourly basis at Urban's current standard rates. Urban's current hourly rate schedule is attached hereto as Schedule "B".
- b. Fees and expenses of consultants to Urban for services where approved by Client, shall be paid by Client in the amount invoiced to Urban, plus five percent (5%) for handling and indirect costs.

If the Client requests and authorizes work to be expedited beyond the production of a normal work day, Urban will attempt to meet such requested schedule, and the fee for such overtime work will be invoiced at 1.5 times the normal billing rate.



<u>SECTION 6 – CLIENT RESPONSIBILITIES</u>

Client agrees to provide full reliable information regarding its requirements for the Project and, at its expense, shall furnish the information, surveys and reports, if any, listed below. In addition, Client agrees to provide, at its expense and in a timely manner, the cooperation of its personnel and such additional information with respect to the Project as may be required from time to time, to be provided by Client for the performance of Urban's work. Client shall designate a Project Representative authorized to act on behalf of Client with respect to this Contract and agrees to render any decisions promptly to avoid unreasonable delay to the Project and the performance of Urban's work. It shall be the responsibility of the Client to obtain permission for Urban, its employees and subcontractors, to enter onto the subject property to perform Engineering and Surveying Services in accordance with the scope of this Contract, prior to the execution of this document. The Client shall provide (where applicable) the following:

- 1. Title Report (if required)
- 2. Any required submission and permitting fees
- 3. Wetland permitting (if required)
- 4. Urban Forestry inspections and recommendations
- 5. Specification Package
- 6. Private utility coordination

SECTION 7 – OTHER TERMS

Town of Vienna Standard Terms and Conditions shall apply.
