This Deed made and entered into this 3rd day of November, 1924, by and between Charles W. Gorham, widower, party of the first part; and Amanda E. Payne, party of the second part:-

Witnesseth: That the party of the first part, for and in consideration of the sum of One Thousand Dollars, the receipt of which is hereby acknowledged, does grant, bargain, sell and convey, with general warranty of title, unto the party of the second part, with all rights, ways, easements and improvements thereunto belonging, that certain tract or parcel of land situated in Falls Church Magisterial District,

Fairfax County, Virginia, which was conveyed to the said Charles W. Gorham by Ray T. Bailey and Mary R. Bailey, his wife, by deed dated the 15th day of October, 1901, and recorded in Liber I, No. 6, page 65 of the land records of said County, and therein bounded and described as follows:
