The Town is proposing to install 5 Capital Bikeshare stations on Town owned property within the Town limits. The station locations are based on a 2019 City of Fairfax study: Fairfax - Mason - Vienna Bikeshare Feasibility Study done by the City of Fairfax. The proposed is being funded by VDOT/Federal TA Funds along with local funds.
