## To whom it may concern

- A. Manita Music Center is a private music lessons and retail piano sales business. Our primary focus is on providing one-on-one private music lessons and the sale of pianos. These lessons serve as an educational part offering customers the opportunity to learn and develop their musical skills.
- B. Our plans to control any potential impacts of the proposed use on the nearby community.

#### Noise

- a. Noise levels anticipated from all uses and equipment:
- All piano lessons are private (one-on-one), conducted indoors, and do not generate excessive noise.
  - The rooms are acoustically treated to prevent any noise disturbances.
- b. Statement on compliance with town noise regulations:
  - Noise levels will fully comply with the Town of Vienna noise ordinance.
  - No outdoor speakers or amplifiers will be used.
- c. Plans to control anticipated noise levels, including noise from patrons or visitors:
- Piano instruction is one-on-one and scheduled by appointment, ensuring a controlled environment.
  - All lessons take place within an enclosed and acoustically treated space.

#### **Odors**

- There are no odors generated from this business.
- No food preparation, chemicals, or hazardous materials are used.

## **Trash & Litter Management**

a. The type and volume of trash and garbage the proposed use will generate:

- Manita Music Center generates minimal waste, primarily consisting of office supplies, paper, and packaging materials.
- There are no hazardous materials, excessive waste, or special disposal requirements.
- b. The planned frequency of trash collection:
- Trash will be collected according to the Town of Vienna's commercial waste collection schedule (weekly).
  - Additional pickups can be scheduled if necessary.
- c. Planned methods to prevent littering on the property, streets, and nearby properties:
- All trash will be disposed of in designated commercial bins to prevent littering.
  - Regular maintenance will ensure the property remains clean at all times.
- Employees and contractors will be instructed to follow proper waste disposal procedures.

## Loading/Unloading

- a. Availability and adequacy of off-street loading facilities:
- The location has a dedicated and spacious entrance for loading/unloading without interfering with pedestrian or vehicle traffic.
- All piano deliveries are scheduled outside peak hours to ensure smooth operations.
- b. Hours and frequency of off-street loading:
  - There will be no off street loading or unloading
  - No daily commercial deliveries or freight unloading.

#### Parking & Traffic

- A. There are 21 dedicated parking spaces available for customers and students.
- Since lessons are one-on-one and by appointment, there is no congestion or traffic issues.
- Drop-off and pick-up will be smooth due to the large, well-organized parking area.
- B. Plan showing the geometric design of stacking aisle and number of stacking spaces provided:
- The parking lot is independent and commercial, with a spacious entrance and exit designed for smooth vehicle circulation.

- The lot has clear designated parking spaces, with ample room for cars to enter, park, and leave without congestion.
- Since our business operates on an appointment-only basis, there is no stacking of vehicles or overflow into public roads

## **Use Capacity**

- a. The estimated number of patrons, visitors, clients, pupils, and other such users:
- A maximum of one student at a time is present for lessons. There will be 5 lessons maximum at the same time, since its one-on-one lessons the maximum number of people would be 10-12 including instructors.
  - Piano sales are by appointment only, reducing foot traffic.
- b. The proposed number of employees, staff, and other personnel:
- No employees only independent contractors working by appointment. We currently have 4 contractors so total of 6 people working there including owners.

# **Hours of Operation**

- Operating hours: Monday Saturday, 11:00 AM 8:00 PM.
- No late-night operations or after-hours activities.

## **Compliance with Zoning & City Regulations**

- The location is fully commercial and aligns with zoning requirements.
- No structural modifications, demolitions, or renovations required.
- We are committed to following all city regulations to ensure a smooth and compliant operation.
