CONTINUING CONDITIONS

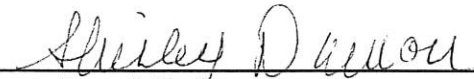

Request for approval of a master sign plan for Danor Plaza Shopping Center located at 401-409 Maple Avenue, E, and 116-124 Branch Road, SE, (Docket No. BAR-22-13), in the C-2 General Commercial zoning district; filed by P. Daniel Orlich c/o Jerry Forker.

The applicant is requesting approval for a master sign plan for a portion of the Danor Plaza Shopping Center. As the shopping center is split between two owners, this application only pertains to those tenants of P. Daniel Orlich. The proposal would change the background color of the existing sign cabinets and portions of the free-standing sign to a green color, similar to that found on the existing "Fresh Market" sign.

The applicant proposes to strip the existing cabinets to their metal base and repaint them with the proposed green color. A color sample been included in the application, however the exact paint type has not been identified. The existing lettering, including font and color, would not change on any sign. The size of the existing signs would not change.

The new green color will apply to the existing building façade signs noted below (refer to staff file for exact sign wording):

In addition, the applicant proposes to paint portions of the existing freestanding sign in the color green. The new paint would apply to the upper portion of the sign which reads "Danor Plaza" and the lower base, as indicated in the submittal. Staff recommends that, in addition to the sign face, the sign edges also be painted green to match.

Staff notes that this master sign plan applies only to the existing signs. The applicant has not provided any standards for the inclusion of new signs. As such, any new signs or re-facing of existing signs would require Board review and approval the future.

Further, the Board may wish to discuss the timing of the proposed improvements. It would be appropriate for all signs to be painted at the same time so as to provide some continuity in the shopping center. It is not clear whether this is the intent and whether all tenants have been consulted regarding the timing.

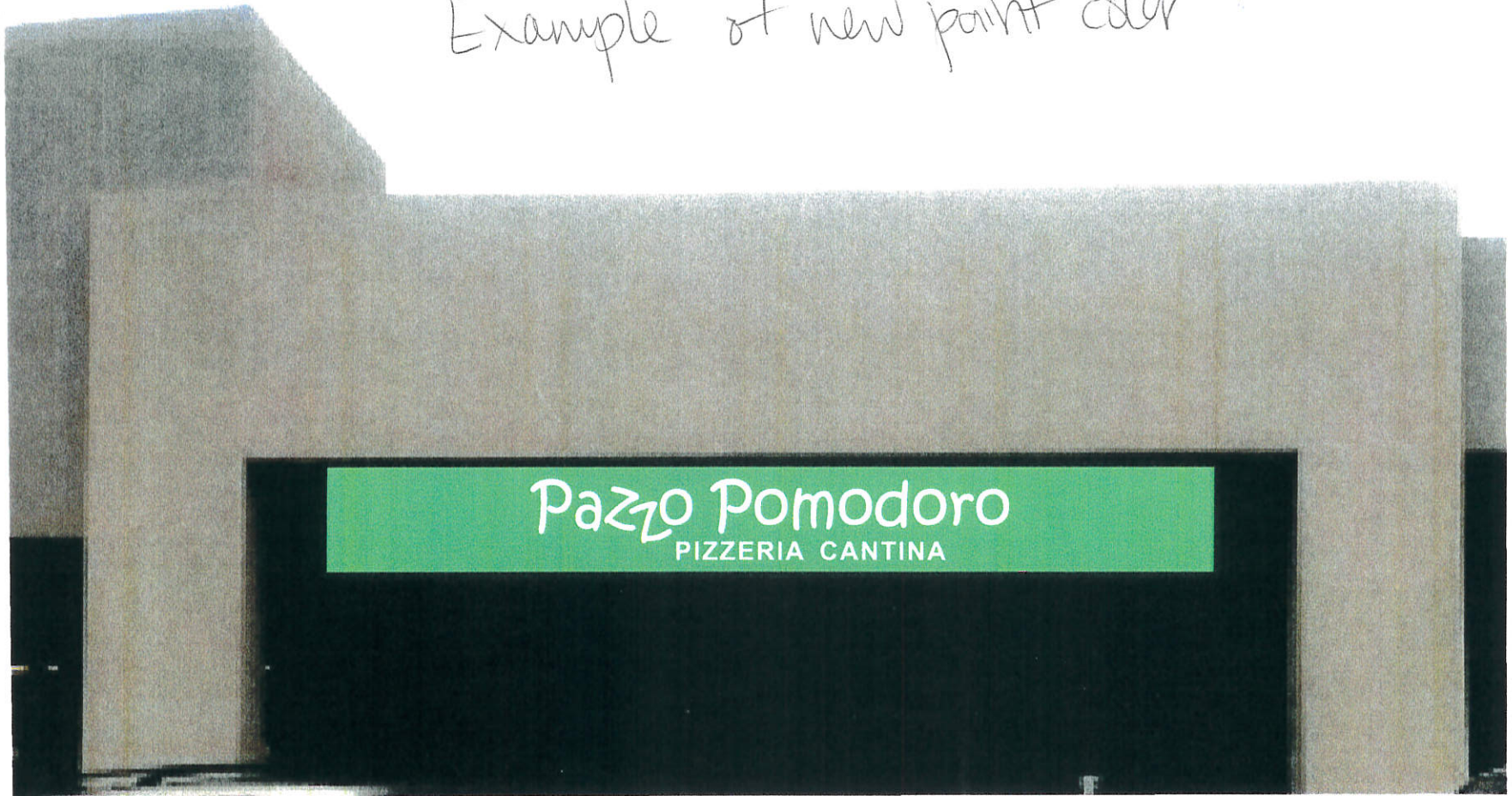

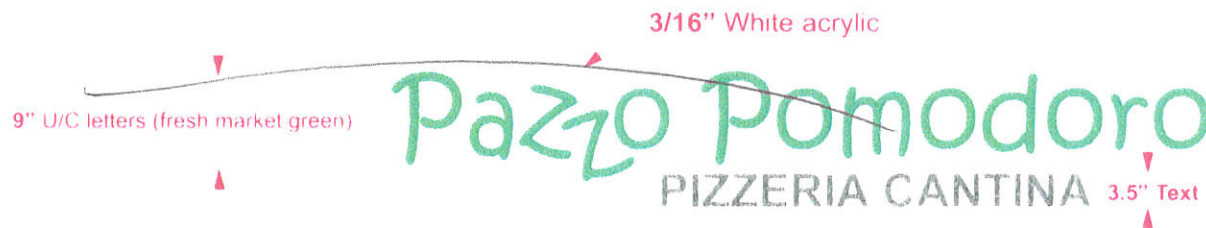
