Notice of Zoning Violation - May 8, 2024

Appeals of Zoning Administrator Determinations

Per <u>Section 15.2-2311. Appeals to board.</u> of the <u>Code of Virginia</u>, and <u>Section 18-820 Appeals of Zoning Administrator Decision</u>, of the <u>Town of Vienna Zoning and Subdivision Ordinance</u>, the recipient of any Notice of Violation has the right to appeal the written order within 30 days of the date of the notice.

On May 8, 2024, the Zoning Administrator delivered a Notice of Zoning Violation to the applicant, regarding the applicant's lack of compliance with the approved site plan on the referenced properties. The site plan was approved on June 9, 2021.

On June 7, 2024, the applicant's representative, Sara Mariska of Odin, Feldman, Pittleman hand-delivered, to the clerk of the Board of Zoning Appeals, the request to appeal, which is attached to this memorandum. The applicant has thereby met the 30-day timeline.

Summary of Determination

The appeal challenges the Zoning Administrator's determination that the subject properties have not been maintained in a condition that is compliant or moving toward compliance with any approved site plan since the previous hotel and restaurant structures were demolished in May 2022. In the three subsequent years, no additional progress has been made towards compliance, including that no building permit has been obtained. The current site has temporary construction fencing that is no longer "temporary", has open foundations, construction debris onsite, and there is no building permit or site plan approval for the current state of the site. Therefore, the subject properties are in

violation of <u>Section 18-836 Site Plan Review</u> of the <u>Town of Vienna Zoning and Subdivision</u> <u>Ordinance</u>.

Decision of the Board of Zoning Appeals

The Board's decision today is whether to 1) uphold the determination of the Zoning Administrator, or 2) overturn the decision of the Zoning Administrator regarding the Notice of Violation issued on May 8, 2024.

Potential motions:

- I move to **uphold** the Zoning Administrators Determination dated May 8, 2024, for the properties at 430 Maple Avenue W (0383 02 0141), 440 Maple Avenue W (0383 02 0140), and 444 Maple Avenue W (0383 02 0139), stating a violation of *Section 18-836 Site Plan Review* of the *Town of Vienna Zoning and Subdivision Ordinance*.
- I move to **overturn** the Zoning Administrators Determination dated May 8, 2024, for the properties at 430 Maple Avenue W (0383 02 0141), 440 Maple Avenue W (0383 02 0140), and 444 Maple Avenue W (0383 02 0139), stating a violation of *Section 18-836 Site Plan Review* of the *Town of Vienna Zoning and Subdivision Ordinance*.


