Fiscal Impact of Legislative Agenda Items**

Item	Description	Financial Impact
6	Orderly implementation of body worn cameras	\$45-50k a year State-provided funding
8	Change road funding formulas for VDOT	Unknown, but large. Over \$1 million annually? See attachment
9	Maintain local authority to approve use of Right of Way	\$20k - \$50k annually
11	Include new sidewalk projects in HB 2313 funding	Unknown but could be large
12	Permit competitive procurement for construction under \$200k	Town has millions of dollars annually with contracts under \$200k; exact benefit positive but amount unknown

Legislative Agenda Item:

The Town of Vienna supports a change to the VDOT local road maintenance funding formula from lane mileage to lane volume: or, in the alternative, request changes that provide additional funding to localities that maintain their roads and have roads that exceed the statewide average traffic volumes for such types of roads by more than 20%. In addition, the Town of Vienna supports a change to the composition to the Commonwealth Transportation Board to have greater representation of the urban/dense suburban areas of the Commonwealth.

Predicted Fiscal Impact:

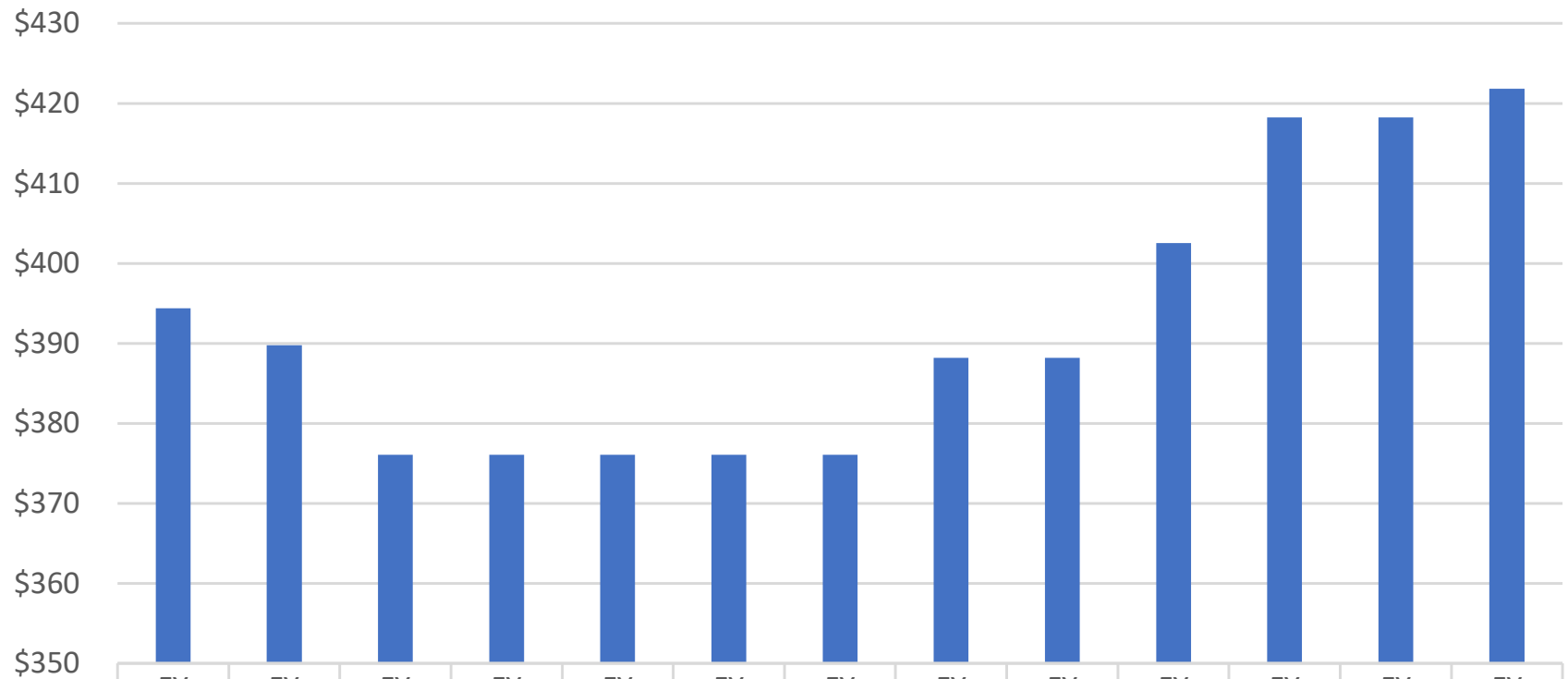
In FY 23, the Town received approximately \$2M in funding from VDOT for roadway maintenance. This funding allocation is based on the Town's approximate 133 moving-lane-miles. VDOT's funding formula is based on the length of principal/ minor arterials and collector/local roads. See the table below for Vienna. This legislative item requests that VDOT determine funding based on vehicle volume instead of moving-lane-miles. The extent to which the Town's funding will increase based on this legislative change is determined by the details of the updated formula. The Town predicts a significant increase due to the volume of traffic experienced in the Town.
