Good Morning Ms. Murphy:

My name is Kathy Isaac. My husband, Chris, and I live at 111 Elm St. SW. Our home abuts The Annex backing up to the corner of the main entrance and the back parking lot.

We are on record with our Town Council opposing the use of Motorcycle Training by our Police Department as a Conditional Use of The Annex. As our Town Leadership continues to address this request, we thought it best to explain our opposition again. Could you please forward this to all members of our Planning Commission?

There have been two of our officers trained at The Annex to date. Both times, it was extremely unpleasant. The motorcycles are very loud. There is a trainer and a trainee, So often there are two motorcycles running drills for hours just beyond our fence. Forget about being outside on a beautiful day, one can barely think inside. For our dog, it's the equivalent of fireworks going off for hours, so she is distressed in the basement. Not at all an enjoyable time at our home.

After the first training exercise, we reached out to our Police Department and asked that they find another location. They promised they would, then did not. So options that allow them to train close to Vienna, but with more space and screening are:

- 1) Nottoway Park – literally just outside town limits
- 2) Wolftrap Farm Park – about 2 miles outside town limits
- 3) Town of Vienna's Public Works facility off of Mill St. Once the trash trucks clear out every morning, there is quite a bit of open space and we believe it is zoned for Commercial Use.

Our Fire Department trains at Fairfax County facilities. Until The Annex was purchased, that is where our Police Department trained as well. While not as convenient, not quite sure why there needs to be different training models for different first responders. So returning to where they trained for many years, also an option.

Our Chief has commented that the motorcycle test is very difficult. Difficult tests require lots of training. We obviously want our Police Department to be well trained. We're just asking that they choose a location that is considerate of their neighbors.

We plan on attending Wednesday's meeting.

I'm writing on behalf of my household (Stephanie and Wesley Payne) at 121 Cherry Circle SW. While our home does not directly abut the annex space, we want to express our full support for our neighbors' concerns and add our voices to theirs.

Regarding the upcoming Planning Commission and Zoning Commission meetings that will consider conditional use for the annex space, we want to be clear that we strongly oppose permitting police motorcycle training on the site. Even when only one motorcycle is in use — let alone multiple — the noise is disruptive and intrusive to the surrounding neighborhood. It seems reasonable that the Town consider better-suited alternatives for this type of training, such as the fire station parking lot or the prior training location used before the Town acquired the annex property.

Additionally, we believe the proposed hours of use are far too broad. We urge the Town to limit permitted hours so they are consistent with the restrictions already applied to home construction and landscaping activity in residential areas.
