Code Create Vienna: Review and Discussion of Article 3 - Uses and Use Standards and Article 4 - Single-Unit Detached Residential Uses

Mayor Colbert opened the Town Council Conference Session at 9:15 PM calling on David Levy, Director, Planning Commission to lead a continuation of the discussion from the February 13, 2023 conference session on the latest draft of Article 3 - Uses and Use Standards.

Comments are summarized as follows:

- Newly added use categories not needed; May encourage unusual usage on empty land;
- Consider removing College and University usage from residential; Potential to outgrow space; Detrimental to residential living;
- Consider eliminating data centers due to noise and water consumption;
- Consider Town Houses in Transitional Zone;
- Specific Uses and Standards upper story residential, first floor should be commercial only inclusive of lobby; Mixed support for removing any requirement for commercial on upper floors;
- Consider adding specific language regarding live entertainment;
- Consider incentives for additional streetscape;
- Special Use permit process should be reevaluated.
