Dear Mayor Colbert and Respected Council Members,

We write to express significant concern over the continuation of the outdoor dining allowance in Vienna. Who doesn't like outdoor dining, particularly in the spring and fall? We love it and have enjoyed it here in our beloved town. However, if the restaurant or bar backs up to a residential neighborhood, the noise that these establishments create is a public nuisance to the residents, so much so that it affects their enjoyment of their own homes.

Just the other night a neighbor two doors down had a small gathering. With our windows open, we could hear the laughs, the guffaws, the clanging of the glasses, etc., and this was a group of fewer than six, I estimate. Restaurants that serve many, many more people make much more noise. In this situation, it would be hard to enjoy one's own backyard or living room/bedroom with open windows. Isn't this the right of every resident who has purchased a home here in the town? Would you like it if a next-door neighbor had a party for 50 every night in their backyard? You wouldn't, and I imagine would complain about this as being unreasonable.

From our perspective, the best option would be to allow outdoor dining in all areas of the town *with the exception of those establishments that abut residential streets.*

Less desirable alternative for these situations only:

- Allow outdoor dining until 8 p.m. on the weekends only, when demand for dining is high. The timing here is in line with the Town's own Noise Ordinance.

Subject: Outdoor Dining Noise Levels

Mayor Colbert and Town Council Members:

As we have written several times in the past 18 months, the noise levels in our backyard, adjacent to Bazin's/Blend have been intolerable since outdoor dining was added in the areas behind the building.

We have put up with the noise as a way to support our community during the pandemic, but we are opposed to extending this permanently. Our backyard sounds like the inside of a busy restaurant for all the hours that dining is open, as well as hearing the setup (leaf blowers at 4:00 pm every day!) and cleanup noise. It is relentless and intrusive. We are unable to enjoy our backyard as we were able to for the 17 years before the pandemic. When there are parties or events in these outdoor spaces, the noise level is even more excessive. We have called the police with a noise complaint on one occasion when there was live amplified music.

For all the years that Bazin's was open pre-pandemic and only operating an indoor dining establishment, we never had any noise issues. When people are dining indoors, the noise stays indoors with them.

We have no issue with outdoor dining in town, as long as the noise associated with that dining does not impact local residents. According to the list accompanying the meeting agenda for next week, Bazin's and Blend are the only restaurants with outdoor dining that are adjacent to residential property. All other outdoor dining spaces face commercial areas.

I know that both Blend and Bazin's are encouraging customers to write in favor of outdoor dining. I'm sure all those customers who enjoy the outdoor dining that makes our yard intolerably loud are then able to return to their own quiet homes and enjoy their peaceful backyards. Most of them probably have no idea that there are houses just behind that brick wall surrounding the patio dining area.

I also hope that our voices, as long-time Vienna residents, will carry more weight than the voices of non-residents who may enjoy an occasional meal in our Town.

Thank you for thinking about the residential impacts of this ordinance and making our neighborhood quiet again.
