Scope of Services

Subtask 1 - General Consulting Support Services

Kimley-Horn will provide Vienna with planning and related support services on an as needed basis and on a mutually agreeable schedule to assist with feasibility analysis as the Town of Vienna considers a public-private partnership for the development of a mixed-use development with public parking garage.

SCHEDULE

Kimley-Horn will provide our services as needed and requested by Vienna. Schedule for services will be provided on a mutually-agreeable schedule as needs arise.

FEE AND BILLING

The Consultant team will perform the services described in the Scope of Services for a fee not to exceed the amount of \$19,897.15 based on the labor classifications, estimated hours, and expenses. Since this task provides for support services on an as-needed basis, work is anticipated on this task until the budget amount is met or until support services are no longer needed. Services above the budgeted amount will be considered additional effort that will require a new task order.

A breakdown of the fee is shown on Attachment A. Since this task order is for services on an asneeded basis, the actual expenditure of hours may be different than those shown in Attachment A.



The fee estimate uses the latest approved rate schedule which is shown in Attachment B as Amendment 3 to Fairfax County Contract #4400003237.
