As an Associate member of the Automotive Lift Institute, ATA prides itself on having a staff of highly qualified, factory certified technicians. ATA currently has 9 ALI certified lift inspectors in the field providing valuable and necessary annual lift safety inspection.



## **Importance of ALI Inspections**

The ALI Lift Inspector Certification Program provides third-party qualification of vehicle lift inspectors and certifies those who demonstrate they are capable of properly inspecting vehicle lifts in accordance with the ANSI standard governing vehicle lift inspection.



Annual vehicle lift inspections conducted by a "qualified automotive lift inspector" are required by the ANSI National Standard covering vehicle lift operation, inspection, and maintenance (ANSI/ALI ALOIM current edition) and included by reference in regulations in the United States.

## How a service call is dispatched:

Service is requested by calling our main office in Fairfax at 800-347-3440, or by emailing <u>service@alantylifts.com</u>. If call is received after normal business hours, our Service Manager, Megan Malone's cell number is provided in the voice mail message. Emails to service are received by Megan Malone, Dave Bradley, and Becky Shay to ensure no request is missed.

Service tickets are entered into our Electronic Service Control (ESC), and the service ticket is dispatched to the technician closest to the service location. The dispatch is received via the ESC app on their smart phone or device.

Each dispatch contains information such as address, phone, contact, shop hours, and specific instructions. In addition, pertinent info including lift model numbers, serial numbers, and service history are available to the technician for reference.

## **Annual ALI Inspections:**

The ALI inspection form for each lift is completed electronically by the certified inspector. The results of the inspection are reviewed with and signed by the shop manager or person having authority. The completed form is emailed to the contact listed on the inspection form for the customer, and to the main office of ATA. An electronic database of all inspections performed is maintained by ATA.

## Installation and Construction:



ATA has a staff of professional lift installers to install new lifts or replace old equipment. We can provide and install reels, wash systems, or shop accessories including air compressors, exhaust systems, lube equipment, tanks and turnkey shop installation. Our staff can provide recommendations for equipment as well as comprehensive estimates and project management. We hold a Class A Contractors License in Virginia, North Carolina, Maryland, Delaware, West Virginia and DC, and can serve as either General Contractor or sub-contractor.
