Request for Town Council to Take Action to Mitigate Tree Loss in Vienna

Dear Town Council:

We are writing because we are concerned about the loss of trees in the Town of Vienna. There are 100 or more home teardown/rebuild projects in Vienna each year. Many of these projects result in the loss of mature trees. In 2022, Davey Resource Group measured the change in Vienna's tree canopy and determined that, in the 10 years from 2011 to 2021, Vienna lost 13% of its tree canopy, a decrease in canopy from 44.5 % to 38.7%. This amounts to a loss of about 163 acres of tree canopy. Some areas of town had a decrease greater than 30%.

We ask Town Council to take action to mitigate the loss of trees, and to take the following actions as soon as possible:

- 1. Enact the Tree Conservation Ordinance authorized by the Virginia General Assembly and in Place in Fairfax County. \(^1\)
 - 2. Establish a Tree Commission. 2
- 3. Establish a Tree Planting Budget and Track and Publish the Number of Trees Planted on Town Property Each Year. ³

Fairfax County adopted a tree conservation ordinance in 1990. Vienna, has not, to date, adopted a tree conservation ordinance. Vienna currently has a tree <u>replacement</u> ordinance. Under Vienna's tree replacement ordinance, builders must submit a plan for replacement of trees, but there is no requirement to preserve or make an effort to preserve existing trees.

We ask Town Council to help mitigate Vienna's tree loss by adopting the tree conservation ordinance that was authorized by the Virginia General Assembly and has been in place in Fairfax County. The tree conservation ordinance will also allow higher tree canopy requirements for some residential lots in Vienna (a 25% tree canopy in 20 years requirement, rather than the current 20% in 20 years).

¹ The Virginia General Assembly allows localities in the Chesapeake Bay watershed the authority to adopt a tree <u>replacement</u> ordinance. (Section 15.2-961). The replacement ordinance does not require the preservation of trees but does specify the replacement of trees that are cut down. The General Assembly also granted certain localities in Planning District 8 (which includes Vienna) the authority to adopt a tree <u>conservation</u> ordinance. (Section 15.2-961.1). The tree conservation ordinance allows minimum tree canopy requirements to be met through the preservation or replacement of trees. However, when existing trees meet standards of health, condition, and suitability, and when it is feasible to preserve those trees, <u>all efforts shall first be made to meet the tree canopy requirement through the preservation of trees before tree planting</u>.

² Vienna maintains a Conservation and Sustainability Commission, but Vienna does not have a commission that is solely focused on trees. A tree commission can advise on the planting, design, maintenance, management, and removal of street, park, and other public trees. It can sponsor tree planting events and raise community awareness about the importance of trees. Nearby communities such as Fairfax County, the City of Falls Church, Arlington County, and the Town of Leesburg have tree commissions. We ask Town Council to establish a Tree Commission that will serve and benefit the Town of Vienna.

³ Every dollar spent on planting and caring for a public tree yields benefits that include cleaner air, lower energy costs, improved water quality and storm water control and increased property values. We ask the Town to increase the budget for tree planting on Town Property and publish the number of trees planted each year. This will allow the Town and its residents to know how many trees are being planted on Town property each year.

I support Vienna's attempts at retaining and even increasing tree canopy. However, as a resident/owner of a non-confirming lot, significantly smaller than most RS-10 parcels of land, I urge the Town to consider **adjusting the percentage of canopy coverage in accordance to the size of the lot.** For example, our lot is about 7500 sq feet, 25% smaller than the RS-10 designation (10K). In this example, the Tree Canopy requirement on a lot of this size would be adjusted down by 25%, from the proposed 20% coverage to 15% (75% of the 20%). In lots that are larger, perhaps their Tree Canopy coverage should be adjusted up.

Secondly, I strongly encourage the Town to pressure (or incentivize if need be) developers to leave existing trees in place! The fact that developers clear cut lots of their beautiful, mature trees is irresponsible.

Members of the Planning Commission,

The builder's group of Vienna has 5 local residential builders and 2 civil engineers that have experience in the Town. We meet with Town staff every other month to refine or implement processes related to new single-family homes and other related topics.

About 2 years ago, several of our members were engaged with the Town Arborist and Mr. Land for discussions on canopy coverage and tree preservation. We appreciate early discussions that will impact our businesses.

Since then some work has been done in formulating the proposed ordinance. As a group we consider this a policy decision and will refrain from opining on those discussions.

While we are happy to comply with whatever changes the town determines appropriate for the ordinance, we would like to express our concerns about the implementation of this policy. Our main goal is to ensure that this new policy will not cause delays in conducting our business. We find that the successful implementation of new policies requires fully developed check lists, clearly defined terms and clearly defined processes. Additionally, a delayed effective date gives staff time to prepare these items.

Our members, including a consulting arborist that submits dozens of plans to the town request collaboration on the implementation of this policy. This engagement happens frequently with new policy and/or code. The Town has proven in the past to excel when a meaningful level of collaboration is utilized.

Hello Jennifer. Thanks again for sharing the information about the proposed changes to the town's tree ordinance and creation of a tree commission. I have a few comments and questions.

First, after reviewing all of the information provided, I recommend adopting a new tree ordinance. In my opinion, it's a much cleaner read and covers the essential points fairly well.

I am pleased to see that the town is proposing something consistent with Fairfax County standards. I wish there was a way to increase minimum tree canopy requirements beyond the 25% standard, but realize that this is unlikely given the need for compatibility with other state and county standards.

The ordinance is clear about applying to property (I assume private?) that is being developed. Will the same standards and a tree conservation plan be required for projects on public areas owned and maintained by the town? Having the same requirements apply across the board would help convince many skeptical residents that the town is taking this issue seriously. Having witnessed damage to or the destruction of so many healthy trees during the renovation of the community center and recently the construction of new sidewalks using the Maud Robinson funds, it makes sense to me to have consistent standards for maintaining and restoring the town's entire tree canopy. The town has a perfect opportunity currently to demonstrate leadership through its deliberations over the future use of the old Baptist Church property on Center Street and Northside Park. A good time to step up the talk into meaningful action.

The ordinance indicates that the Director of Recreation and Parks will have a large role in reviewing and monitoring tree conservation efforts. I assuming that this means that qualified arborists on staff will be engaged in this work, correct? I realize that this is beyond the ordinance topic, but will the town have enough qualified staff to handle the expanded workload?

Having a tree commission with a balanced membership is a good idea. How will this new commission interact with the town's sustainability committee? It seems to me that both entities would benefit by interacting regularly, as long as it does not add another bureaucratic layer to the process. While beyond the scope of the tree ordinance, the town-wide tree conservation plan should be modified to address the proposed changes.

Finally, I see the role of community engagement and information sharing as a key responsibility of the tree commission. Since much of the recently lost tree canopy (160 acres) has been on private property, it is really important to encourage property owners to consider substituting current practices for a more ecological friendly approach. This also means providing the means and skills to assist the tree commission in fulfilling its work.

I hope these comments are useful.

CHAPTER 122. Tree Conservation Ordinance. 29 - TREE CONSERVATION

ARTICLE 1. General Provisions GENERAL PROVISIONS

Section 122Sec. 29-1-1.- Title.

This <u>C</u>chapter shall <u>hereafter</u> be known, <u>cited</u>, <u>and referenced to</u> as the "<u>Vienna</u> Tree Conservation Ordinance" <u>of Fairfax County</u>.."

Section 122Sec. 29-1-2.- Authority.

This chapter is enacted pursuant to the authority and mandates of: Va. Code Ann. § §§ 10.1-1127.1, 15.2-961, and 15.2-961.1.

Section 122Sec. 29-1-3.- Enactment.

This Chapter shall be effective at 12:01 a.m. on January 1, 200924.

Section 122 Sec. 29-1-4.- Areas of a Applicability.

This <u>Cc</u>hapter and all regulations adopted hereunder shall apply to all land located within the <u>unincorporated areas of Fairfax County. Town of Vienna.</u>

Section 122 Sec. 29-1-5. Purpose and intent.

The purpose and intent of this Cchapter is to provide for the conservation and management of Town trees, and to provide for the conservation of trees during the land development process. The conservation (i.e., preservation and planting) of trees during the land development process will protect, sustain, and enhance the CTownty's urban forest resources. These forest resources provide important aesthetic, social, and economic benefits and are indispensable to the conservation and management of vital atmospheric, water, soil, and ecological resources.

Section 122Sec. 29-1-6.- Administration.

The Director of <u>Land Development ServicesParks and Recreation or his designee</u> shall be responsible for the administration and enforcement of this $\underbrace{\mathsf{C}}_{\mathsf{C}}$ hapter.

Section 122Sec. 29-1-7. Severability.

If any of the articles, sections, paragraphs, sentences, clauses, or phrases of this Cchapter shall be declared unconstitutional or invalid by a valid judgment or decree of a court of competent jurisdiction, such unconstitutionality or invalidity shall not affect the validity of this Cchapter in its entirety or any of the remaining articles, sections, paragraphs, sentences, clauses, and phrases herein.

ARTICLE 2. Tree Conservation During Land Development DEFINITIONS

Section 122Sec. 29-2-1. Definitions

(a) ARTICLE <u>82. DEFINITIONS</u>

- (a) Clearing_means removing or causing to be removed the vegetation growing in the soil which protects and stabilizes the soil. Such removing or causing to be removed shall include any intentional or negligent act to: (1) cut down, (2) remove all or a substantial part of, or (3) damage a tree or other vegetation which will cause the tree or other vegetation to decline and/or die. Such acts shall include but not be limited to damage inflicted upon the root system of the vegetation by the application of toxic substances, by the operation of equipment and vehicles, by storage of materials, or by alteration the damage of the natural grade due to unapproved excavation or filling; or damage caused by the unapproved alteration of natural physical conditions.
- (b) Director means the Director of the Department of Land Development Services.
- (b) Critical root zone means the minimal surface area and associated underground root system and soil that must remain undisturbed in order for a tree to survive significant soil disturbing activities such as

- compaction, cutting, grading, or filling that will occur in close proximity to the tree. The Critical root zone is defined by a circle whose radius starts at the center of the tree's trunk and terminates in any direction at the outer boundary of the area that must be left undisturbed in order to ensure tree survival.
- (c) Forested area: Areas means areas comprised of self-supporting tree and woody plants that exceed five feet in height at time of plan submission and meet criteria for health, condition and suitability as further defined in this section. Areas that meet the administrative definition provided above usually represent native forest or woodland plant communities that occur in a range of successional stages from rapidly changing early successional pioneer woodlands (often described as "scrub") to stable long-term subclimax and climax forests. During mid to late successional stages, these plant communities typically consist of multiple layers of vegetation and other natural features including: super- and sub-canopy tree species; woody shrubs, herbaceous plants, vines, non-vascular plants and epiphytes; decaying leaf litter, root mass, fungi, soil biota; and abiotic components which the vegetation is dependent upon such as: soils, hydrologic conditions, and underlying geomorphic features.
- (d) Tree: Any means any self-supporting woody plant which visually produces one main trunk and a more or less distinct and elevated head with many branches that typically reach at least 15 feet in height at maturity, and for purposes related to ten20-year tree canopy requirements exceeds five feet in height at time of plan submission.
- (e) Tree canopy coverage: The land area directly beneath the crown and within the dripline of a tree, or in the case of a group of trees or a forested area, the coalesced area directly beneath the overlapping crowns of trees whose boundary is defined by the extents of its outermost driplines.
- (e) Tree canopy includes all areas of coverage by plant material exceeding five feet in height, and the extent of planted tree canopy at 20 years maturity. Planted canopy at 20 years maturity shall be based on published reference texts generally accepted by landscape architects, nurserymen, and arborist in the community.
- (f) Tree Conservation: As (f) Tree conservation, as applied to trees and forested areas, tree conservation incorporates both tree preservation and tree planting efforts.

ARTICLE 3. TREE CONSERVATION DURING LAND DEVELOPMENT

Sec. 29-3-1. Ten Year Tree Canopy Requirements.

(a) All land development requiring the submission of a site plan, preliminary subdivision plat, subdivision construction plan, conservation plan, grading plan, or a rough grading plan, shall provide for the conservation of trees on the site such that, after ten (10 twenty (20)) years, minimum tree canopy is projected to be as follows:

(b) For purposes of administering the above requirement, land development does not include: construction of additions to existing residential structures; construction of residential accessory structures; demolition of existing residential structures; reconstruction of residential structures on existing foundations; construction associated with minor site plans; construction of trails, sidewalks, sanitary sewers, storm sewers, and other public improvements of a linear nature not included as part of a larger common plan of development; and, other land disturbing activities that present a minor threat to existing tree resources as determined by the Director of Parks and Recreation.

Section 122Sec. 29-3-2-2. Standards for 10-year Tree Canopy Requirements.

- (a) The 10 year tree canopy requirement requirements set forth in Table 1 above may be met through the preservation or planting of trees. However, when existing trees meet standards of health, condition, and suitability, and when it is feasible to preserve those trees within the framework of permissible uses, densities, design standards, and construction practices, all efforts shall first be made to meet the tree canopy requirement through the preservation of trees before tree planting is allowed to meet any portion of the tree canopy requirement.
- (b) Tree canopy credit shall be given to existing areas of trees and forested areas designated to be preserved on plans and comprised of self-supporting and woody plant material exceeding five feet in height at time of plan submission provided that the trees and forested areas meet standards for health, condition, and suitability.
- (c) Any portion of the tree canopy requirement that cannot first be met through the preservation of trees as provided for in §-122-229-3-3 shall be provided through tree planting.
- (d) Tree canopy credits for trees and plant material used to satisfy <u>1020</u>-year tree canopy requirements shall be determined in accordance with the provisions of <u>the Public Facilities Manual (PFM)</u>. <u>Vienna's Tree Preservation and Planting Guide</u>.

Section 122-2Sec. 29-3-3. Tree Preservation Requirements.

- (a) Except as provided for in § 122 2 29-3-3(b), the percentage of the development site covered by tree canopy at the time of plan submission shall equate to the minimum portion of the total 1020-year tree canopy requirement of § 122 2 29-3-2(a) that should be met by means of tree preservation. This minimum portion shall be identified in plats and plans as the "tree preservation target."
- (b) Deviations, in whole or part, from the tree preservation target may be requested under the following conditions:
 - 1. Meeting the tree preservation target would prevent the development of uses or densities otherwise allowed by the Town Zoning Ordinance;.
 - 2. Meeting the tree preservation target would require the preservation of trees and forested areas that do not meet standards for health, structural condition, and other vegetation and risk management requirements.
 - 3. Construction activities could be reasonably expected to impact existing trees or forested areas used to meet the tree preservation target to the extent they would not likely survive in a healthy and structurally sound manner for a minimum of ten (10twenty (20)) years in accordance with the post-development standards for trees and forested areas.
- (c) Deviations from the Tree Preservation Target shall be granted for any of the justifications listed above provided that a written request is submitted and approved by the Director of Parks and Recreation. The request must take the form of a letter addressed to the Director of Parks and Recreation that provides a site-specific narrative explaining why one or more of the conditions allowing a deviation set forth in (b) above should be considered. The narrative must also provide the basis for the deviation, a detailed description of how the deviation is the minimum necessary to afford relief and describe how the balance of the 20-year tree canopy requirements could otherwise be met by means of tree planting.²
- (d) The Director of Parks and Recreation may grant additional canopy credits in order to encourage the preservation of forest communities that provide valuable environmental, ecological, and wildlife conservation benefits.
- (e) The Director may grant additional tree canopy credits in order to encourage developers to preserve trees for official designation as heritage, memorial, specimen and street trees as provided in Chapter 120 (Heritage, Memorial, Specimen and Street Tree Ordinance).
- (f(e) All tree and forested areas designated to be preserved on plans shall be protected and managed during all phases of construction.

Section 122-2Sec. 29-3-4. Tree Planting Requirements.

- (a) Tree canopy credit shall be given to areas of planted tree canopy based on the projected <u>1020</u>-year tree canopy calculation as set forth in the <u>PFMVienna's Tree Preservation and Planting Guide</u>, provided that the proposed tree species meets standards established to manage proper levels of biodiversity and the spread of invasive plants, pests, and diseases.
- (b) Tree canopy credits shall be given to tree seedlings, shrubs and woody seed mix planted in large open spaces, low-density residential settings, or in low-impact development projects.

- (c) Additional tree canopy credits shall be granted for the planting of trees that will provide air quality, energy conservation, water quality, wildlife conservation benefits.
- (d) Additional tree canopy credits shall be granted for the use of native tree species, and the use of cultivars or varieties that develop desirable growth and structural patterns, resist decay organisms and the development of cavities, show high levels of resistance to disease or insect infestations, and, exhibit high survival rates in harsh urban environments.
- (e) In order to provide higher levels of biodiversity and to minimize the spread of pests and diseases, or to limit the use of species that cause negative impacts to native plant communities, cause damage to nearby structures, or possess inherent physiological traits that prone trees to structural failure, the PFM designates Vienna's Tree Preservation and Planting Guide may designate trees that cannot be planted to meet tree canopy requirements or that shall only receive partial tree canopy credits.
- (f) All plant materials used to satisfy <u>1020</u>-year tree canopy requirements shall be selected, located, handled and installed in accordance with the <u>PFM</u>. Vienna's Tree Preservation and Planting Guide.

Section 122-2Sec. 29-3-5. Use of Tree Banking and Tree Preservation and Planting Fund if Tree Canopy Requirement Cannot be Met On-Site.

- (a) Where it can be demonstrated to the satisfaction of the Director of Parks and Recreation that the tree canopy requirements set forth in §-122-2_29-3-1 cannot be met on-site, the portion of the requirement that cannot be met on-site may be met through the use of off-site tree banking or through a pro rata payment
 - 1. Fees collected for these purposes will be based on the cost to establish 20-year Tree Canopy Cover using 2-inch caliper nursery stock tree.
 - 2. The cost to establish 200 square feet of 20-year Tree Canopy using 2-inch caliper landscape tree will be set at the unit cost for a 1.5-2.0-inch caliper deciduous tree as stated in the current Fairfax County Land Development Services' Comprehensive Unit Price Schedule.³
 - 3. Any funds collected by the Town for these purposes shall be spent within a five-year period established by the collection date, or the Town shall return such funds to the original contributor, or legal successor.⁴

Section 122-Sec. 29-3-6. Exemptions and Modifications.

- (a) The following uses are exempt from the requirements of this Chapter: bona fide silvicultural activity as defined by Va. Code Ann. §-10.1-1181.1 and the areas of sites included in lakes, ponds, and the normal water elevation area of stormwater retention facilities.
- (b) Deviations of the overall canopy requirements set forth in § 122 2 29-4-1 may be granted by the Director of Parks and Recreation to allow for the preservation of wetlands, the development of farm land or other areas previously devoid of healthy and/or suitable tree canopy, or where the strict application of the requirements would result in unnecessary or unreasonable hardship to the developer.

ARTICLE 3. Plan Requirements. 4. TREE CONSERVATION PLANS

Section 122-3Sec. 29-4-1. Submission and Review of Tree conservation plans. Conservation Plans.

(a) Applicability.

- 1. Tree conservation plans must be submitted for review and approval by the Director of Parks and Recreation as provided below and in this chapter. Tree conservation plans are 1. Section 104 1-2 of the Code states that a conservation plan is-required of anyone engaging for any of the following located in land disturbing activities in the RS-16, RS-12.5, RS-10, RMU, AC, AE, AW, GS, M, CP, T, and NM zones: the development of an undeveloped tract; the County. 2. A tree conservation plan shall be required when land disturbing activity requiring a conservation plan involves the removal, preservation or redevelopment of any existing tract by removal of a dwelling and replacement of trees or forested areas with a new dwelling; or the addition to an existing dwelling that results in an area of disturbed soil exceeding 2,500 square feet.
- 32. Tree conservation plans shallmust be submitted for review and approval by the Director of Parks and Recreation as part of all preliminary subdivision plats, construction plans, and grading plans as required by Chapter 101 (Subdivision Ordinance) of the Code. 4. Tree conservation plans must be submitted as part of all site plans as required by subsection 8101.4 of this Code, and to the extent applicable, Zoning Ordinance.5.

 Tree conservation plans shall be submitted as part of all grading plans for Building Permits on existing lots that are not within a subdivision currently bonded with the Fairfax County Code. County and parcels with lots of 5 acres or more as required by Chapter 104 (Erosion and Sedimentation Control Ordinance) of the Code.
- 63. A site plan, preliminary subdivision plat, subdivision construction plan, conservation plan, grading plan, or rough grading plan approved by the Director of Parks and Recreation and meeting the requirements contained herein shall constitute an approved tree conservation plan. 7. Tree conservation plans and associated plans, narratives, calculations, deviations and modifications shall be prepared in accordance with the PFM Vienna's Tree Preservation and Planting Guide.
- 4. If a tree conservation plan proposes tree removal of off-site or jointly-owned trees because they have critical root zones that extend into the project site and will be encroached on by construction activities causing irreparable damage, a written notice must be sent to the affected adjacent landowner(s) notifying them that tree removal is proposed. The notice shall include a tree conservation plan that shows which trees will be irreparably damaged by the proposed development, and a description of the size, species, and species common name and general location description of the trees and an explanation that the trees have critical root zones that extend into the project site and will be encroached on by construction activities causing irreparable damage. The letter shall explain that 1) the tree(s) are proposed for removal at the developer's expense as part of this proposed development, 2) the designated trees cannot be removed without the property owner's permission, and if the owner chooses to retain the tree(s) despite the severe impacts to the root system, the owner may be responsible for any future corrective measures, including removal. The letter must be sent from the U.S. Postal Service via certified/return receipt, or other service that provides proof of mailing, to all applicable property owners. A copy of the domestic return receipts from the U.S. Postal Service or other proof of mailing of the notification provided with the letters shall be provided with the tree conservation plan submitted to the Town.
- 5. In all cases, off-site trimming or cutting of trees requires permission of all involved landowners.

 Notice of intent to remove a tree does not replace a builder's responsibility to secure permission of adjacent landowners for that work.⁵

- (b) Exceptions to Applicability. A tree conservation plan is not required to be submitted under the following conditions: 1. Those exceptions to land disturbing activity as specified in Chapter 104 (Erosion and Sedimentation Control Ordinance) of the Code.
 - 21. For the removal of trees grown and intended to be sold as live trees in the course of business on nursery or dealer properties registered by the Virginia Commissioner of Agriculture and Immigration (Plant Pest Act of 1952). This provision does not supersede the requirement to obtain an approved conservation plan prior to engaging in any other land disturbing activity.
 - <u>32</u>. A tree conservation plan shall not be required to cut down any tree which has become, or threatens to become, a danger to human life or property due to accidental or natural causes or other emergency.
 - 43. A tree conservation plan shall not be required for the harvesting of trees on commercial forest land if the operation is conducted in conformance with the Virginia Department of Forestry's Best Management Practices. However, when the State Forester is required to be notified of a timber harvesting operation, the operation shall be conducted pursuant to a forest management plan approved by the Director as provided in Public Facilities Manual § 12-0316. A forest management plan shall not be approved for land for which a commitment with the County, such as a proffered condition, has been made to preserve trees.

Sec. 29-4-2. Monitoring and Inspections; One Year Bonding of New Trees.

- (a) The planting of any new tree(s) specified on the tree conservation plan shall take place after the completion of construction. The Department of Parks and Recreation shall inspect the trees prior to planting and also inspect the placement and installation of the tree(s). All products and workmanship related to the planting of the tree(s) shall be in accordance with the Town's requirements as set forth in the Town of Vienna Tree Preservation and Planting Guide. A one-year tree protection bond shall be collected by the Town for all new tree(s). The amount of the bond shall be set by the Department of Parks and Recreation based on the current Fairfax County Land Developmental Services unit pricing. If the tree(s) are thriving and in good condition one year from the date of planting the bond shall be returned. Otherwise, the tree(s) shall be replaced.
- (b) The Department of Parks and Recreation shall also inspect all existing trees after completion of construction to determine what damage, if any, has been caused by the stress of construction. The Department of Parks and Recreation shall notify the permit holder in writing if any existing trees no longer qualify for canopy coverage. The letter shall state if mitigation measures are required to use a tree for canopy coverage. The permit holder shall provide an independent arborist's report to justify retaining a damaged tree or to support mitigation measures. Upon notification by the Department of Parks and Recreation that repairs or replacements to an existing tree are to be made, the permit holder shall make the required repairs and replacements and shall notify the Department of Parks and Recreation when the repairs and replacements are complete. The Department of Parks and Recreation shall inspect the repairs

ARTICLE. 6ARTICLE 5. Satisfying Tree Conservation Requirements.

Section 122-6-1. Sec. 29-5-1. Satisfying Tree Conservation Requirements.

- (a) Approval of a tree conservation plan meeting the requirements of this chapter and subsequent release of all agreements and securities related to the tree conservation plan shall be deemed to satisfy tree conservation requirements except those tree conservation requirements stemming from proffered condition, development plan, conceptual/final development plan, special exception, special permit or variance approvals.
- (b) When required tree canopy is located on individual residential lots, the property owner shall not be precluded from adding, removing, or relocating tree canopy provided that the developer has been released from all agreements and securities related to the landscape plan and the landscaping is not required as part of proffered condition, development plan, conceptual/final development plan, special exception, special permit or variance approvals.

ARTICLE 5. Violations and Penalties. ARTICLE 6. INSPECTIONS, VIOLATIONS AND PENALTIES Section 122-4-1. Monitoring and Inspections. Sec. 29-6-1. Inspections

(a) The Director of Parks and Recreation shall provide for periodic inspections of tree conservation activities in accordance with Public Facilities Manual § 12 0500 Standards for Field Practices, and Chapter 104 (Erosion and Sedimentation Control Ordinance) of the Code this Article and Vienna's Tree Preservation and Planting Guide.

Section 122-5-1. Sec. 29-6-2. Constitution and Processing of Violations.

- (a) Any land disturbing activity and any removal of vegetation contrary to any of the provisions of this Cchapter shall constitute a violation.
- (b) Any person, whether owner, lessee, principal, agent, employee or otherwise, who violates any of the provisions of this Chapter, or permits any such violation, or fails to comply with any of the requirements hereof; or any professional, as defined in 18 VAC 10-20-10, or Certified Arborist or Registered Consulting Arborist, as defined in PFM Section 12-0307.2G, who directs or causes another person to violate any provision of this Chapter, shall be subject to the enforcement provisions of this Article.
- (c) Upon becoming aware of any violation of any provision of this Chapter, the Director of Parks and Recreation shall serve a notice of violation on the property owner, professional, or any other person committing or permitting the violation, either in person or by registered or certified mail. Such notice shall specify the provisions of the Chapter which have been violated, the measures needed to remedy the violation, and a reasonable time in which to remedy the violations. Failure to take steps to comply with such notice within the time provided for therein shall constitute a separate violation of this Chapter.
- (d) The Director of Parks and Recreation, on behalf of the Board of Supervisors Town Council, may apply to the Fairfax County Circuit Court for injunctive relief to enjoin a violation or a threatened violation of any provision of this Chapter.

Section 122-5-2 Sec. 29-6-3. Replacement & Trees and/or & Vegetation.

- (a) Land disturbing activities involving tree removal without an approved tree conservation plan.
 - 1. A tree conservation plan shall be submitted for approval by the Director of Parks and

- <u>Recreation</u> when a violation is issued for land disturbing activity involving tree clearing without an approved plan in accordance with the <u>Erosion and Sedimentation Control Ordinance</u>.
- 2. Replacement trees and/or other vegetation may be required by the Director of Parks and Recreation according to the guidelines set forth in Public Facilities Manual this Article and Vienna's Tree Preservation and Planting Guide.
- (b) Land disturbing activity conducted in violation of an approved tree conservation plan.
 - 1. A revision to the approved tree conservation plan may be required by the Director of Parks and Recreation when land disturbing activities are conducted, without prior approval of the Director of Parks and Recreation, in areas outside the limits of clearing and grading shown on the approved plan resulting in the removal or damage to trees or forested areas designated to be preserved on such plan.
 - 2. Replacement trees and/or other vegetation may be required by the Director of Parks and Recreation according to the guidelines set forth in the Public Facilities Manual. this Article and Vienna's Tree Preservation and Planting Guide.

Section 122-5-3, Sec. 29-6-4. Criminal Violations and Penalties.

- (a) Any violation of the provisions of this Oordinance shall be deemed a misdemeanor and, upon conviction thereof, shall be punishable by a fine of not less than \$10 and not more than \$1000. Failure to remove or abate a violation within the time period established by the Court shall constitute a separate misdemeanor offense punishable by a fine of not less than \$10 nor more than \$1000, and any such failure during any succeeding ten-day period shall constitute a separate misdemeanor offense for each ten-day period punishable by a fine of not less than \$100 nor more than \$1500.
- (b) The remedy provided for in this Section is in addition to any other remedies provided by law-including, but not limited to, violations of Chapters 101 (Subdivision Ordinance), 104 (Erosion and Sedimentation Control Ordinance), 112.1 (Zoning Ordinance), and 118 (Chesapeake Bay Preservation Ordinance) of the Code, however, the designation of a particular violation of this Oordinance for a civil penalty precludes criminal prosecution or sanction, except for any infraction that results in civil penalties that total \$5,000 or more.

Section 122-4. Sec. 29-6-5. Infractions and Civil Penalties.

- (a) A violation of any provision of this Oordinance shall be deemed an infraction and shall be punishable by a civil penalty of \$200 for the first violation; and subsequent violations arising from the same set of operative facts shall be punishable by a civil penalty of \$500 for each separate offense.
- (b) Each day during which any violation is found to have existed shall constitute a separate offense. However, in no event shall any such violation arising from the same set of operative facts be charged more frequently than once in any ten-day period, nor shall a series of such violations arising from the same set of operative facts result in civil penalties which exceed a total of \$5,000.
- (c) The designation of a particular violation as an infraction pursuant to Paragraph (a) above shall be in lieu of criminal sanctions, and such designation shall preclude the prosecution of a violation as a criminal misdemeanor unless such violation results in injury to any person or persons or the civil penalties under Paragraph (a) above total \$5,000 or more for such violation. If the civil penalties for a violation under Paragraph (a) above total \$5,000 or more, the violation may be prosecuted as a criminal misdemeanor.
- (d) After a notice of violation has been served on any person who violates this Oordinance, if the violation has not ceased within the reasonable time specified in the notice, then, upon the approval of the County Town Attorney, the Director of Parks and Recreation shall serve a summons upon such person.
- (e) Such summons shall contain the following information:
 - 1. The name and address of the person charged.

- 2. The nature of the infraction and the Oordinance provision(s) being violated.
- 3. The location, date and time that the infraction occurred or was observed.
- 4. The amount of the civil penalty assessed for the infraction.
- 5. The manner, location and time in which the civil penalty may be paid to the County Town.
- 6. The right of the recipient of the summons to elect to stand trial for the infraction and the date for such trial.
- (f) The summons shall provide that any person summoned for a violation may elect to pay the civil penalty by making an appearance in person or in writing by mail to the DepartmentDirector of Finance at least 72 hours before the time and date fixed for trial and, by such appearance, may enter a waiver of trial, admit liability, and pay the civil penalty established for the offense charged. Such summons shall provide that a signature to an admission of liability shall have the same force and effect as a judgment of court; however, an admission shall not be deemed a criminal conviction for any purpose.
- (g) If a person charged with a violation does not elect to waive trial and admit liability, the violation shall be tried in the General District Court in the same manner and with the same right of appeal as provided by law. A finding of liability shall not be deemed a criminal conviction for any purpose.
- (h) The remedies provided for in this Section are cumulative and not exclusive and shall be in addition to any other remedies provided by law.

Section 122-7-1. Appeals. ARTICLE 7. APPEALS

Any applicant aggrieved by a decision of the Director of Parks and Recreation in the administration of this Chapter has the right to petition the Director of Parks and Recreation for reconsideration of the decision, provided such request is made in writing within fifteen (15) days of the date of the Director's Director of Parks and Recreation's written decision.

ARTICLE 8. VIENNA TREE COMMISSION

ARTICLE 9. Section 122Sec. 29-8-1. Definitions. Tree Commission Purpose-

Section 122-9-1. Tree Commission.

(a) ____Purpose. The purpose of the Tree Commission is to provide advice to the Board of Supervisors, based on an annual reevaluation of the administration and implementation of the provisions set forth in this Ordinance and the landscaping and screening requirements contained in the Zoning Ordinance; to provide leadership in developing an understanding of the objectives and methods of tree conservation; and to assist the Urban Forest Management Division of the Department of Public Works and Environmental Services and Land Development Services in the development and maintenance of technical specifications and guidelines.

(b) *Authority and Establishment.*

1. The Tree Commission was established in conformance with an action adopted by the Board of Supervisors on June 18, 1973 and amended on July 30, 1973, which action became effective on August 1, 1973. 2. The official title of this commission is the 'Fairfax County Tree Commission'. (c)

There is hereby created and established a commission to be known as the Vienna Tree Commission, which shall advise and assist Town Council and Town Staff on matters relating to the conservation and management of the Town's trees and tree canopy and assist the Town in the development and maintenance of specifications and guidelines related to the same.

Sec. 29-8-2. Tree Commission Membership.

1. The Board of Supervisors appoints the Tree Commission members. The Tree Commission may have no more than fifteen (15) members of the following composition: ten (10) citizens of the County chosen for their knowledge and experience in the field of arboriculture or related fields and one representative from each of the following: Fairfax County Environmental Quality Advisory Council, Northern Virginia Soil and Water Conservation District, Fairfax County Park Authority, Fairfax County Office of Virginia Cooperative

Extension and Virginia Department of Forestry.

- 2. Citizen members of the Commission are appointed to serve for a three (3) year term or until their successor has been appointed. An appointed successor to a vacancy serves only the unexpired portion of the term. Members may be reappointed to successive terms.
- 3. If a member is absent for three (3) consecutive meetings without sufficient cause, a letter will be sent to the Chairman of the Board of Supervisors asking for replacement of that member.
- 4. The removal or resignation or withdrawal of any or all members of the Tree Commission does not result in the dissolution of the Tree Commission.

(d) Officers.

- 1. The Tree Commission must have a Chairperson and Vice-Chairperson and such other officers that the Tree Commission elects from time to time.
- 2. Officers of the Tree Commission are to be elected once each year or when an officer withdraws from his post. An annual election meeting will be held as soon as appropriate after regular annual appointments are made.
- 3. The duties of the officers will be in general those defined in Robert's Rules of Order, modified as required to fit the purpose of the Tree Commission.

(e) Meetings.

- 1. Meetings of the Tree Commission are scheduled by the Chairperson, as needed, or upon the request of three (3) or more members. Meetings are held at a time and place to be designated by the Chairperson.
- 2. Robert's Rules of Order govern proceedings of the Tree Commission.
- (f) Records. The Tree Commission must keep records of all its proceedings, and the records must be made available for public inspection upon request.
- The commission shall consist of seven members, all of whom shall be appointed by Town Council. At least one member shall be selected from the Conservation and Sustainability Commission. In addition, a Town representative(s) from the Departments of Parks and Recreation and/or Planning and Zoning shall serve as an ex-officio member(s) of the commission. Except for the Town representative(s), all appointees shall be either residents of the Town or representatives of businesses or professions located in and licensed by the Town. No more than two nonresidents of the Town shall serve on the Tree Commission. In making all appointments to the commission, Town Council shall give consideration to persons who have evidenced an interest or expertise in tree conservation and tree policy.

Sec. 29-8-3. Tree Commission Term of Members.

The term of all members shall be for two years. Initially, four members of the board shall be appointed for a term of one year and three members shall be appointed for a term of two years. Thereafter, all appointments to the commission, except for those to fill an unexpired term, shall be for a period of two years. All members shall serve without compensation. Vacancies occurring on the commission for reasons other than the expiration of terms shall be filled by Town Council for the remainder of the unexpired term. Members shall be eligible for reappointment. Members may be removed from the commission by a majority vote of Town Council.

Sec. 29-8-4. Tree Commission Powers and Duties.

- 1.(a) The Tree Commission has commission shall have the power following powers and duties:
 - 1. To recommend rules, regulations, policies and programs to do any lawful acts the Town Council and Town staff relating to tree conservation and management, the care and improvement of the Town's urban forest, and protecting and enhancing the Town's tree canopy.
 - 2. To advise and assist the Town Council and Town staff regarding the planting, protection, maintenance, preservation, and removal of trees, shrubs, and other plants located on public property within the

Town.

- 3. To advise and assist the Town Arborist to ensure that the planting, maintenance, pruning, and removal of trees and shrubs on public property within the Town are done in accordance with current accepted standards.
- 4. To help develop, maintain, and administer a written plan for the care, preservation, pruning, planting, replanting, removal, or things reasonably disposition of trees and shrubs in parks, along streets, and in other public areas. Such plan will be reviewed annually, updated as necessary to carry out its purposes., and presented to Town Council; upon acceptance and approval by Town Council, such plan shall constitute the official public tree management plan for the Town
- 5. To assist the Town with compiling and analyzing data to measure the Town's progress in restoring the Town's tree canopy.
- 6. To attend and bring back knowledge and information from nearby and online meetings, seminars, and conferences concerning urban forestry.
- 7. To undertake an ongoing program of public outreach and education in order to promote public understanding and support of the Town's public tree management plan and to increase public awareness of the value and benefits of a diversified, sustainable community forest.
- 8. To work with Town staff to compile, publish, and update annually information and statistics regarding the Town's efforts with regard to trees, including a) the amount spent each year by the Town for the purchase and planting of trees, b) the number of trees planted on Town property each year, c) the number of trees on Town property cut down or removed, d) any available data regarding the extent of or changes to the Town's tree canopy, and e) any available data regarding an inventory of the Town's street trees, such as the percentage of street tree planting sites that are filled, and priority street tree planting sites that are unfilled. The commission shall present a report to Town Council each year that includes a description of the commission's activities, key data and statistics, and ongoing and anticipated future activities.
- (b) Town Council shall have the right to review the conduct, acts, and decisions of the Town tree commission. Further, the tree commission, when requested by Town Council, shall consider, investigate, make findings, report on, and recommend any special matter or question coming within the scope of its work.
- <u>.</u>2. The Tree Commission develops and disseminates technical information for professional groups, developers, and citizens, and strives to inform the general public of the provisions of this Ordinance and the landscaping and screening requirements contained in the Zoning Ordinance.
- 3. The Tree Commission assists the Urban Forest Management Division in the development and maintenance of the landscaping and screening requirements contained in the Zoning Ordinance, and the policies, standards and guidelines in the Vegetation Preservation and Planting section of the Public Facilities Manual and other related documents, which will provide guidance for persons involved in planting, preserving, protecting or replacing trees.
- 4. The Tree Commission presents an annual report to the County Executive and Board of Supervisors that includes:
- A. A description of activities conducted.
- B. A report of ongoing and anticipated activities.
- C. An evaluation of the experience of the administration and implementation of the provisions set forth in this Ordinance and the landscaping and screening requirements contained in the Zoning Ordinance including: an appraisal of the strength and comprehensiveness of the provisions; recommendations to improve implementation; and judgment as to how it is being interpreted by the public and by those affected by the requirements of these provisions.
- 5. The Tree Commission will be provided working facilities by the County Executive. Where required,

the Tree Commission will be provided with assistance from other County agencies.

- 6. The Tree Commission may divide itself into ad hoc committees as the Chairperson may direct or the Tree Commission may resolve, and those ad hoc committees may acquire additional assistance from any sources as required to perform assignments so long as they are consistent with the provisions of this Ordinance and the landscaping and screening requirements contained in the Zoning Ordinance.
- 7. The Tree Commission may enact bylaws as may be required to aid in its efficient operation.

ARTICLE 9 TOWN TREE REPORT

Sec. 29-9-1. Annual Tree Report.

- (a) The Town shall compile, publish, and update annually information and statistics regarding the Town's efforts with regard to trees, including a) the amount spent each year by the Town for the purchase and planting of trees, b) the number of trees planted on Town property each year, c) the number of trees on Town property cut down or removed, d) any available data regarding the extent of or changes to the Town's tree canopy, and e) any available data regarding an inventory of the Town's street trees, such as the percentage of street tree planting sites that are filled, and priority street tree planting sites that are unfilled.
- (b) The information and reporting described in (a) above shall be published each year, including on the Town website.

Good evening. I am Brian Land. I live at 504 Ridge Rd SW in Vienna.

Back in 2019, I pitched an idea to the Town of Vienna. I noted that, with the new home construction in town, the town was losing its mature trees. I suggested a project to interview other communities to learn how Vienna might make use of other communities' lessons learned and advice, in order to do a better job managing and preserving trees in Vienna.

The Town approved the project in 2020. My law firm, Kirkland & Ellis, agreed to allow me to conduct the project on a pro bono basis (free of charge to the Town). We worked with Christina Caplan, chair of Vienna's Conservation and Sustainability Commission, who helped with the project and co-authored the report.

As part of the project, 1) we interviewed more than 50 individuals, including tree policy experts, 2) we reviewed Vienna's tree laws, 3) we reviewed tree laws in other Northern Virginia communities and 4) we reviewed tree studies that had been prepared for other cities and counties.

From our interviews and research, we learned the substantial benefits trees provide to communities, including Vienna. In particular, trees provide benefits to Vienna of \$4.3 million each year in terms of carbon storage, stormwater absorption, removal of air pollutants, and other benefits.

That was the good news. The not-so-good news is we learned that Vienna is losing its tree canopy. Vienna experienced a 13% decrease in its tree canopy in the 10-years from 2011 to 2021, and some areas in Vienna had a decrease of more than 30% of its tree canopy during that 10-year period.

In October 2022, we delivered our tree report to the Town. The report has 12 principal recommendations. The first recommendation is that trees should be prioritized as critical community infrastructure in Vienna. Much like buildings, streets, and sewer lines, trees are part of the infrastructure that improves our quality of life. Trees provide Vienna with significant environmental, health, safety, and economic benefits.

The second is that to preserve existing trees, Vienna should update Vienna's existing tree <u>replacement</u> ordinance by adopting a tree <u>conservation</u> ordinance, which is authorized under Virginia Code Section 15.2-961.1 and is in place in Fairfax County.

Fairfax County adopted the tree conservation ordinance is 1990. Vienna, however, has never had a tree conservation ordinance. Vienna's tree replacement ordinance specifies that trees must be planted or exist at the time of occupancy to meet a certain canopy projection 20 years after the site development. But Vienna's tree replacement ordinance does not require any effort be made to preserve existing trees. It allows lots to be completely clear cut of the existing trees.

Fairfax County's tree conservation ordinance requires tree canopy projections to be met, either through the preservation or replacement of trees. However, when existing trees meet standards of health, condition, and suitability, and when it is feasible to preserve those trees, the tree conservation ordinance specifies that "all efforts shall first be made to meet the tree canopy requirement through the preservation of trees before tree planting." That is the key distinction between Vienna's tree replacement ordinance and Fairfax County's tree conservation ordinance. The tree conservation ordinance requires efforts be made to preserve trees.

You have before you two approaches for updating Vienna's tree ordinance. Option A would establish a new Chapter in the Town Code that would set forth Vienna's Tree Ordinance. Option B would make changes to Chapters 17, 18, and 27 of the Town Code.

I recommend that Vienna adopt Option A. You may have seen this table that compares 15 aspects of Option A and Option B. Given the limited time, I am only going to talk about a couple items, which are the first two items in the table.

Item 1 is Where Should Vienna's Tree Ordinance be Placed in the Town Code? My recommendation is that the Tree ordinance should have its own Chapter in the Town Code. Why? First, placing the Tree Ordinance in its own Chapter will make it clear that the Tree Ordinance intended to apply to all property development. BACKGROUND FOR 9/8/23 PLANNING COMMISSION MEETING

Hello. I am Christina Caplan. I have been on the Conservation and Sustainability Commission for the past 7 years and Chair for the past 3 years. I am here to provide some background information on the tree ordinances that have been proposed to Town Council and are currently before the Planning Commission for review.

PRO BONO STUDY/REPORT

2019 – Brian Land approached CSC with idea of pro bono project to figure out how to stop the clearcutting on redeveloped lots in town

Tree preservation has been an issue for CSC for years, particularly with respect to infill lots, so we were happy to team up

Took about a year of working to get a proposal approved by Town Council

Sept. 2020 – Town Council approved pro bono project to be conducted by Kirkland & Ellis (law firm), Ramboll Consulting (environmental firm), and CSC

Project involved

- interviews with more than 50 stakeholders and tree experts
- research and analysis of regulations, policies, and programs in other jurisdictions (federal, state, and local)
- review of tree reports prepared for other communities

Culminated in lengthy report released in October 2022 outlining our findings and recommendations to help Vienna preserve and manage its tree canopy

Recommendations included:

- Prioritizing trees as critical community infrastructure
- Strengthening and consolidating Town Code provisions relating to trees into one single tree ordinance
- Establishing a Vienna Tree Commission
- Increasing tree planting on Town property
- Establishing a budget specifically for tree planting

- Increasing awareness of the environmental, health, safety and economic benefits of trees
- Compiling and analyzing data on trees in Vienna, including UTC assessment (with ecosystem benefits and planting map) and street tree inventory
- Conducting early arborist review of new construction projects
- Providing incentives for builders to conserve trees during the construction process
- Requiring bonding for preserved and newly planted trees on redeveloped lots (Vienna now only collects bonds for Town street trees that may be impacted by new construction; Town Code (17-15T and 18-252E) seems to allow collection of Tree Protection Bonds with certifications for any trees designated to be preserved on a site plan for both subdivisions and single lots)
- Limiting paving of front yards to allow space for trees
- Establishing a nonprofit Vienna Tree Foundation that can receive grants and donations and can plant trees on private property
- Enlisting resident volunteers to nurture newly planted town trees
- Expanding Arbor Day into a group tree planting day throughout the town

Brian and I presented report to Town Council in May 2023 and since then have spoken at several other Town Council meetings about tree issues.

CURRENT ORDINANCE

The reason we are here tonight is to move ahead with one of the main recommendations in our report, which is to adopt a tree preservation ordinance for the Town

Under VA State Code, localities are authorized to adopt tree ordinances under two sections.

- Section 15.2-961 allows localities to adopt a tree *replacement* ordinance
- Section 15.2-961.1 allows localities in Planning District 8 (which includes Vienna) that are in nonattainment for ozone to adopt a tree *conservation* ordinance

Vienna currently has a tree replacement ordinance.

It was adopted in 1991 and originally applicable only to new subdivisions.

In 2014, at the urging of the CSC, the tree replacement ordinance was extended to single lot development/ redevelopments.

Vienna's current tree replacement ordinance has a **20% in 20 years** requirement: Builders are required to submit a plan for planting and replacement of trees on site during development so that, at 20 years in the future, the lot will be covered by a minimum of 20% tree canopy in RS-16, RS-12.5, and RS-10 zones.

Vienna's ordinance allows existing trees to be preserved to meet all or part of the tree canopy requirements, but there is no requirement to preserve or make an effort to preserve existing trees.

Because Vienna is in Planning District 8, the Town is authorized **under 15.2-961.1** to adopt a **tree conservation ordinance**

Tree conservation ordinances are structured differently than replacement ordinances and offer additional tools to protect canopy.

- 1. They allow minimum tree canopy requirements to be met through the preservation or replacement of trees but **require preservation attempts first** when existing trees meet standards of health, condition, and suitability, and when it is feasible to preserve those trees. ("all efforts shall first be made to meet the tree canopy requirement through the *preservation of trees* before tree planting.")
- 2. They require **tree preservation targets** to be set based on the percentage of the site covered by tree canopy at the time of plan submission. Targets equal the minimum portion of the applicable canopy requirement that must be met through tree preservation.
- 3. They set **5-10% higher minimum tree canopy requirements based on units per acre** (25% for residential sites zoned 3-4 units per acre and 30% for residential sites zoned 1-2 units per acre). Means some residential lots in Vienna (**RS-16, RS-12.5**) would have a **25% tree canopy in 20 years** requirement, rather than the current 20% in 20 years.
- 4. They allow for **deviations from both the tree preservation target and the minimum tree canopy requirements** under certain conditions:

- **Preservation Target**: Deviations are allowed if (1) target would prevent allowed zoning uses and densities; (2) vegetation does not meet local standards for health and structural condition; (3) construction impact on health and structural condition of trees.
- Developers must request deviation in writing and describe how minimum tree canopy requirements will be met through tree planting or a tree canopy bank or fund.
- **Minimum canopy**: Deviations are allowed (1) for preservation of wetlands; (2) for development of farm land; and (3) if requirements would result in unnecessary or unreasonable hardship to the developer.
- 5. They require establishment of a **tree canopy bank OR fund** whereby any portion of tree canopy requirements that cannot be met on-site may be met through off-site tree preservation or tree planting efforts. *Developers must demonstrate that: requirements would cause irresolvable conflicts with local site development requirements, standards, or comprehensive planning goals; sites lack sufficient space for future tree growth; planting spaces will not provide adequate space for healthy root development; trees will cause unavoidable conflicts with underground or overhead utilities; or trees are likely to cause damage to public infrastructure*
 - Tree canopy funds may be used for planting on public property or may be disbursed to nonprofit tree planting groups.

PROPOSED ORDINANCE

As part of pro bono report, we developed a model tree ordinance that includes a tree preservation ordinance instead of Vienna's current tree replacement ordinance.

The tree preservation ordinance in the report is based on Fairfax County's preservation ordinance, which has been in place since 1990 and successfully implemented.

Throughout our interviews for the project, many people recommended that we look to Fairfax County as a model for tree preservation because it is using every tool available in the tree toolbox – legislative and program-wise.

Many interviewees recommended that Vienna model its tree policies on Fairfax County and use its similar authority under state law to adopt a tree preservation ordinance in lieu of a replacement ordinance.

The preservation ordinance proposed is therefore very similar to that of Fairfax County, with some differences and modifications that are now up for discussion.

For example, Fairfax County is authorized to adopt a 10-year canopy requirement because of when its ordinance was adopted, whereas Vienna can only adopt a 20-year requirement.

Some provisions in the proposed ordinance are found in Fairfax County's Public Facilities Manual, rather than the ordinance itself.

The bonding requirements are not in the Fairfax County ordinance but are based on those in Falls Church's ordinance.

I also want to point out that the proposed preservation ordinance is structured as a stand-alone ordinance, rather than as part of the Subdivision and Zoning Code sections in the Town Code.

This was done intentionally. Other jurisdictions we looked at have stand-alone tree ordinances, which can be easily amended or added to (for example, if Vienna were to adopt a heritage tree ordinance at some point in the future). It also makes tree-related requirements easy to find, although obviously it would require references to the tree ordinance in zoning code sections setting forth requirements for subdivision and single lot development.

TREE BOARD/COMMISSION

Finally, the proposed ordinance also includes a section establishing a new Tree Commission.

The CSC supports having a separate entity focused solely on trees, although the exact structure is up for discussion.

We currently constitute the Town's Tree Board under Section 27-5 of the Town Code. Our efforts have been focused on education and policy, but we have had "legislative wins" in the past.

- Spearheaded extension of tree canopy replacement ordinance from subdivisions only to single lot redevelopment
- Helped update Tree Planting and Preservation Guide by making the tree list all native
- Educate residents about trees through articles in the Vienna Voice, the annual Green Expo, and weekly Green Tips
- Conducted seedling giveaways for past 2 years
- Help Vienna celebrate Arbor Day and meet its Tree City USA certification

That said, we have a broad mission covering many issues – energy, water, trash, recycling, composting, native plants – and more issues crop up each year (light, noise, leaf mulch) so our bandwidth is limited.

We support having a separate entity with additional resident volunteers – whether a subcommittee or separate commission – focused solely on trees. They could

- Expand on CSC initiatives
- Find funding and grants for planting
- Work with town staff to help with increasing planting, data gathering, and education
- Implement the 100+ recommendations in the pro bono report

I see benefits to both proposed structures for a tree board or commission, but I would request that whichever is chosen, CSC members be included to ensure communication and coordination and draw on existing expertise and interest.

REMARKS: 9/27/23 PLANNING COMMISSION PUBLIC HEARING

My name is Christina Caplan and I am Chair of Vienna's Conservation and Sustainability Commission (CSC). I presented background on the tree preservation ordinance at your meeting 2 weeks ago. I am speaking at tonight's public hearing as both CSC Chair and a Vienna resident.

I have 2 main points to make.

First, I fully support adopting a tree preservation ordinance that is authorized under Virginia State Code. I am a lawyer, as is Brian Land, and we both understand and adhere to the need to operate within the bounds of the applicable legal framework.

For Vienna, that means the Dillon Rule applies, so anything the Town adopts must be based on powers that are (1) expressly granted by the state; (2) necessarily or fairly implied from powers that are expressly granted; or (3) essential to accomplishing the purposes of the locality.

Both versions of the tree preservation ordinance that have been presented for review have been carefully vetted to ensure they are authorized by state law. The Town Attorney's version adheres strictly to what is in the authorizing statute (known as Section 15.2-961.1). The more "aspirational" ordinance (aka the Brian Land version) extends beyond 961.1 but is based on what has been adopted by other jurisdictions like Fairfax County and Falls Church.

Concerns about authority for specific provisions in the extended ordinance – for example, bonding requirements and technical details – are warranted but easily remedied.

The technical language may very well belong in the Town's Tree Planting and Preservation Guide rather than in the ordinance itself, similar to how Fairfax County operates. As an administrative lawyer, this to me makes good sense.

Bonding requirements in other jurisdictions are based on the Chesapeake Bay Preservation Act and the state's subdivision code. They also appear to be authorized by the Vienna Town Code itself under Sections 17-15T and 18-

252E. These sections allow collection of Tree Protection Bonds with certifications for any trees designated to be preserved on a site plan for both subdivisions and single lot redevelopment.

As the Town Attorney noted on Monday night, there may also be *implied* authority for certain provisions in the ordinance.

My second point goes to process. The purpose of public hearings by the Planning Commission AND by Town Council is to ensure discussion and debate on proposals that matter to Vienna residents.

This requires members of both bodies to listen, read, analyze, ask questions, and then work to develop an ordinance that Town Council is comfortable with and has clear authority to enact. For the tree ordinance, both bodies should:

- Review staff memos that lay out issues and decisions to be made.
- Understand the Town Attorney's valid concerns about ensuring legality of any ordinance that is adopted.
- Listen to residents' concerns about decreasing tree canopy as each old house is torn down along with every mature tree on the lot.
- Read the reports from contractors *hired by the Town* that provide data to back up what people are seeing and saying and that even quantify some of the economic value of Vienna's tree canopy.

This is the reasonable and responsible approach to adopting a tree ordinance.

Refusing to hold a public hearing on an issue already referred to the Planning Commission is counterproductive and derails an established process. I hope that the Planning Commission's public hearing tonight can remedy some of the damage done by Town Council on Monday night. Work and thought needs to be put in by all Council and Commission members to get the process back on track and adopt an effective tree preservation ordinance for Vienna.
