What is a Comprehensive Plan?

- Long-range, high-level planning document that addresses land use, desired development, preservation of the natural environment, transportation, resource utilization and potentially other topics.
- Community's vision for how it wants to evolve in the following 20+ years, with strategies to achieve that vision.
- Basis for regulatory tools such as zoning and subdivision ordinances, and for capital improvements.



Value of Comprehensive Plans

- Give successive public bodies a common framework for addressing land-use issues.
- Guide and protect public investments.
- Allow communities to plan development in a way that protects valued resources.
- Provide guidance for shaping the appearance of the community.
- Promote economic development.
- Provide justification for decisions by providing a factual and objective basis to support zoning decisions.



How is the Plan Implemented?

- Update regulations (e.g., zoning)
- Capital Improvement Plan and operational budget.
- Community plans and programs that deal with specific subjects; i.e. Housing Studies, Parks & Recreation Master Plans, and Small Area Plans






Phase 1: Information Gathering

Phase 1: Information Gathering

- Kick-off community meeting
- Input from Boards and Commissions
- Discussions with staff in relevant departments
- Data collection








Phase 2: Compilation & Draft Development

- Staff brings together all input and organizes by element
- Planning Commission work sessions to review and provide staff with guidance
- Staff works with subcommittees to develop draft plan





Phase 3: Refine the Draft

- Planning Commission reviews draft of entire plan
- Community Input meeting(s) to provide comments on the draft prior to formal hearings
- Planning Commission directs staff to make any edits based on community feedback and reviews draft for approval prior to hearing





Phase 4: Finalize the plan

- Share the hearing draft of the plan with the community and advertise
- Planning Commission hearing(s)
- Planning Commission holds work sessions to review and direct staff to make any desired edits
- Planning Commission vote to recommend draft to Town Council
- Joint work session with Council and Planning Commission
- Town Council public hearing(s)
- Town Council work session(s)
- Town Council votes to approve and adopt; approve with edits; send back to the Planning Commission to make changes;....






Phase 1 Public Engagement
