- Due to phasing of work, CCA will absorb any extra delivery or storage fees
- All work done by CCA will be ADA compliant
- Stair nosing if needed will be furnished and installed by CCA at no extra cost

EXCLUSIONS:

- Removing second layer of tile-(cost will be added if needed)
- Removal or Abatement of anything that disturbs Lead Based Paint is excluded
- Disconnecting and moving of computers, personal property and electronic equipment
- Moving any furniture
- New wall base-(we will leave existing stained oak base)
