EXPLANATION AND SUMMARY

Staats Developers and Alma and Jack Tochterman have expressed interest in purchasing the adjacent, unopened mid-block alley between their properties. In accordance with our new policy, all Town departments and utility companies were contacted for comment on the proposed vacation of public right-of-way and had no objection. The right-of-way is a maintenance problem for the Parks and Recreation Department tree crew who have spent several days removing large overhanging trees in the last few years. It is unlikely the alley will ever be opened for any type of public use.

The applicants are only interested in purchasing the portion of the alley directly adjacent to their properties. Vacating this small portion of the whole alley will not land lock any other properties but will prevent opening the alley all the way through the block for public use in the future. Town Council may wish to pursue vacation of the remainder of the alley at this time; however, it is recommended that any additional vacations not create landlocked parcels which cannot be maintained by Town crews.

Public rights-of-way have value and any disposal must follow state law. The extra land may improve adjacent properties and allow for a building addition or even provide enough property to allow a subdivision. Because the applicants would be receiving something of value, staff feels it is important that the applicants not only purchase the public property but pay all associated costs for the vacation and abandonment like field survey, title search, plat preparation, recording fees, etc.

Town Attorney Recommendation:	The Town Council may consider the proposed vacation of right of way in its discretion and in accordance with state law. Under the Town's vacation of ROW procedures, if the Town Council wishes to consider the proposed vacation, the following procedures should be followed: Page 3 of 73

Town Council decides if the land appears to be surplus

and confirms the requester is responsible for the fees to implement disposal of the parcel. A fee and up-front payment of field survey, deed research, plat preparation, appraisal, filing fees, etc. should be required. Article 2, Chapter 20, of Title 15.2 of the Code of Virginia specifies the procedure for appointing viewers, determining values, etc., for any vacation of street rights-of-way.

If Council choses to move toward disposing of the property, the requestor (or the Town at the requestor's expense) hires a licensed surveyor at their expense to confirm parcel ownership and to produce a report explaining how the land was originally deeded to the Town and for what purpose. The surveyor shall give their professional opinion on who the property reverts to when vacated.

The surveyor prepares the appropriate plats and deeds of vacation at the requestor's expense.

If the surveyor concludes the parcel does not revert to adjacent property owners as a result of a subdivision and the parcel may be sold, the Vienna Town Attorney hires an appraisal firm at requestor's expense.

Public Notice and final Council action. Public Works staff prepares a second Town Council agenda report for discussion at a regular Council meeting. Public Works staff will notify Town boards and commissions, post "public hearing" signs on-site and send meeting notice letters to property owners adjacent to and affected by the proposed abandonment and approval of the "ordinance of vacation". At Town Council vote of three-fourths of all members of the Town Council is required for approval of the sale of any Town real estate.

Public Works staff's agenda report will include the surveyor's report, plat and deed; comments and correspondence from all agencies and other interested parties; then recommend a final disposition.

Recording of Ordinance/Deed. If the Town Council authorizes abandonment, sale or other disposition of the property, the requestor shall pay the value of the parcel. The Town Attorney records the "ordinance of vacation" and deed and any unspent survey fees are returned to the requestor.

Town Manager's Recommendation:

I recommend the Town Council begin the process to dispose of the excess public alley right-of-way between 108-110 Church Street NE and 120 Church Street NE as presented.
