- A: Per the units permitted on the property, lower level, facing the road (Church Street), each tenant, per the landlord approval, will be permitted to have:
 - (2) 3mm ACM Board Sign Inserts (1 per side) located on the freestanding entrance unit.
 - (1) VINYL sign, directly above the storefront, on the awning.
- B: All characters, design(s) and color(s) will be subject to the landlord's prior approval and the guidelines provided within this document.
- C: The content on the awnings or the entrance sign shall be limited to the sole name of business and shall not, in any way whatsoever, include logos, multi-color letterings, phone numbers or anything besides the legal name of the business and will require approval from the landlord before tenant can submit to Town of Vienna for the Sign Permit approval.
- D: Unless otherwised advised, each tenant will be required to submit to the landlord (3) copies of the shop drawings per awning or entrance sign inserts, to scale, noting the material of the sign, the overall size, the colors and provide a drawing that shows placement of said sign(s) superimposed onto the correct location and elevation of proposed new sign(s).





- Painted or printed signs, moving signs, rooftop signs, parapet or pylon signs, outrigger signs
