Request for approval of exterior modifications for Virginia Tire & Auto of Vienna at 141 Maple Ave. W, (Docket No. BAR-15-18), in the C-2 General Commercial zoning district; filed by Michael Holmes, business representative.

The applicant proposes a new building façade, multiple signs, landscape improvements and updating the existing freestanding sign. Staff would like to note that the Board held a work session with the applicant in March 2018. The Board was generally supportive of the application. Suggestions included improvements to the existing pylon sign and use of thin brick above the existing roofline near the front corner of the building.

1) **Building Façade:** Façade update to include painting of existing brick, refinishing of storefront, and replacement of garage doors. Improvements include construction of new architectural and screening elements around existing roofline.

- 4) **Landscape:** Several planting materials will be planted within a brick box planter surrounding a wooden bench. The proposed planting materials are Karl Foerster Grass, Yellow Whild Indigo, Crape Myrtle Bush, and Blue While Indigo.
