For more information, go to www.fairfaxcounty.gov/taxes. The registration fee is shown on your personal property tax bill as "Local Registration Fee" and is due October 05, 2018. This is a Fairfax County local registration fee only - there is no county windshield decal.

### Attention Town of Clifton, Herndon and Vienna Residents

Local town ordinances have been amended and there is no longer any requirement to display a local registration decal on vehicles regularly garaged within the **Towns of Clifton**, **Herndon** and **Vienna**. Although a windshield decal is no longer required, pursuant to Virginia law each town still charges a local registration fee. These fees are now prorated based on the purchase or sale of the vehicle, or relocation outside of these jurisdictions. Moreover, each town has entered into a compact with the County of Fairfax whereby the County is now collecting local registration fees on behalf of each town. The town fee, as applicable, is now shown on the same bill with any Car Taxes owed to the County of Fairfax. #### Tax Relief

- Seniors 65 or older or individuals who are totally and permanently disabled may qualify for relief from some taxes and fees based on income and assets, excluding the home and up to one acre of land.
- Qualified disabled veterans residing in Fairfax County can receive a tax exemption on their home and up to one acre of land, as well as tax relief on one motor vehicle owned and regularly used by the disabled veteran. Exemption applications are available online at the Department of Tax Administration (DTA) website below.
- Spouses of Veterans Killed in Action: Effective Jan. 1, 2015, if you are a surviving spouse of a veteran who has been killed in action, you may be eligible to be exempted from real estate taxes on your principle residence. Under state law, you are not eligible for this tax exemption if you have remarried.
