All modification requests shall be accompanied with the following information:

1. Twelve (12) folded copies--with all corrections as required by the **Planning Commission**--of the site plan modification request including the application and checklist of required information, plus all data for the original submittal, as required by Section 18-252 of the Town Code, and any revisions incorporated into one (1) electronic copy of the entire submission-including a completed version of this application-in Portable Document Format [PDF].
2. A written explanation to the Directors of Public Works and Planning and Zoning, in a separate letter **and** incorporated onto the site plan sheet itself, of the requested site plan modifications. Such explanation shall describe, in accordance with § 18-256, how the most practical, efficient or aesthetic development of the subject property cannot be achieved within the requirements of Chapter 18 of the Town Code.
3. A comparison of zoning district requirements in conjunction with the requested modifications.
4. A separate list indicating the names and addresses of all owners of record for all properties adjacent to, abutting or across a public street from the subject tract. (This information may be easily obtained on-line at the following Internet address:
