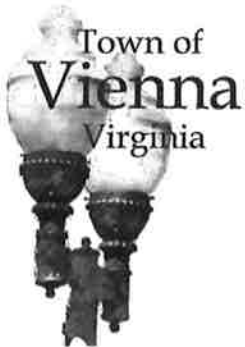

## **Background**

As my memory allows me, the love of caring for children rooted in my soul since I was six years old. At that young age, I loved to help out my relatives babies at all family gatherings. Feeding the babies, rocking them to sleep were the greatest joy for me.

After graduating from high school, I continued my education in Bachelor of Arts. During my education, some of my favorite subjects were social studies and human development. My career involved in retail management. Employee and customer satisfaction were the core of my focus. Our daycare business came about after my first child was born. I felt the need to stay home to raise him. When he turned six, I tried to return to old management position. The company informed me that I could not leave everyday at two o'clock to be with my children when they came home from school.

My family needed my extra income to survive. After studying various options, opening a family daycare made the most sense for my family. I could be home with my children and could provide the much needed income. We started small with just immediate neighbors and before long the word of mouth came into play. Today, our daycare (Happy Younglings) is one of the top reviewed and praised among "Vienna Moms INC".

Since the year 2002 (the year my first child was born), I have been dedicating my time to educate myself in all aspects of early childhood developments through research. I attended more than one-hundred and seventy hours of Fairfax County trainings that have helped to polish my learnings since Happy Younglings establishment. I am MAT and Adult/Pediatric CPR and First Aid certified.

## **Location**

Happy Younglings is located in Vienna Wood Zoning. Our address is: 108 Yeonas Circle SE, Vienna VA 22180. We are close to Town of Vienna downtown(Route: Park Street, Cottage & Center Street), Vienna Metro (Route: Marshall Road), Tysons Corner and Dunn Loring (Cedar lane, Electric Avenue & Idylwood Road).

## **Outdoors Play Area**

Our outside play area designated for the daycare is a very large fenced playground. The total outdoors use for daycare is 15,000- 20,000 SqFt. The yard is fully fenced (Six Feet Tall) and some parts are double fenced. There are two gates at the yard Entrance/ Exit for safety. Handicap access to the daycare's yard Entrance/Exit and to the playground are available.

## **Indoors Area**

As the pictures exhibit, the designated space for daycare is located in lower level of our split level single family house with lots of Windows and the total of three Emergency Exits/ Entrances. Our Nursery room has been designed and furnished with all necessary furnitures (Cribs, Shelves for health products, Sink and safe Toys) for our infants. There

is also a full bathroom for employees use in the nursery area which has been separated by a safety gates. Our main room has been fully furnished for infants, toddlers & preschoolers. There are 8 standard cots are used for daily naps for our toddlers and preschoolers. There are Two kitchen areas inspected and approved by Fairfax County Fire Marshall. The main kitchen area (20x10 SqFt) is located on the upper level and is consisted of an oven, a refrigerator, a stove, a large sink and used for all the food preparation. The auxiliary kitchen (5x10 SqFt) in the daycare area is consisted of a double sink, a side by side refrigerator and a microwave. The auxiliary kitchen is used for storing and serving the prepared food. There is a full bathroom next to the auxiliary kitchen area with a wall-changing table, a toilet and a sink to be used for changing and potty training the young scholars. The total indoors used for daycare is 1200 SqFt.

The total parking spots offered to our customers by us is five cars. The total of public parkings available for our customers (after every neighbor is parked) are four. In addition, we have decided to express our gratitude to our supportive neighbors by expanding our driveway and add two more parking spaces to our existing driveway. We

have received our permit from Town of Vienna for driveway expansion and it will be starting as soon as we find the right contractor to do the job. Please note that our drop-offs and pick-ups are staggered from 7:30 a.m. to 6:00 p.m. and there will be seven to eleven available parkings for non-resident guests to be used for a short period of time. Our proposal will make the arrivals and dismissals for both neighbors and customers smoother than ever.

### **Employees**

We have two employees whom assist us from Monday to Friday all year around. Our full-time employee works from 7:30 a.m. to 3:00 p.m. She is certified MAT (EPEN), Adult/Pediatric CPR and First Aid. She also completes sixteen hours of child development trainings through OFC every year. She does not park her vehicle on Yeonas Circle and walks to the daycare daily.

Our part-time assistant works from 3:00 p.m. to 6:00 p.m. She is an Adult/Pediatric CPR and First Aid certified. She also completes sixteen hours of child development trainings through OFC yearly. She does not park her vehicle on Yeonas Circle and walks to Happy Younglings every day.

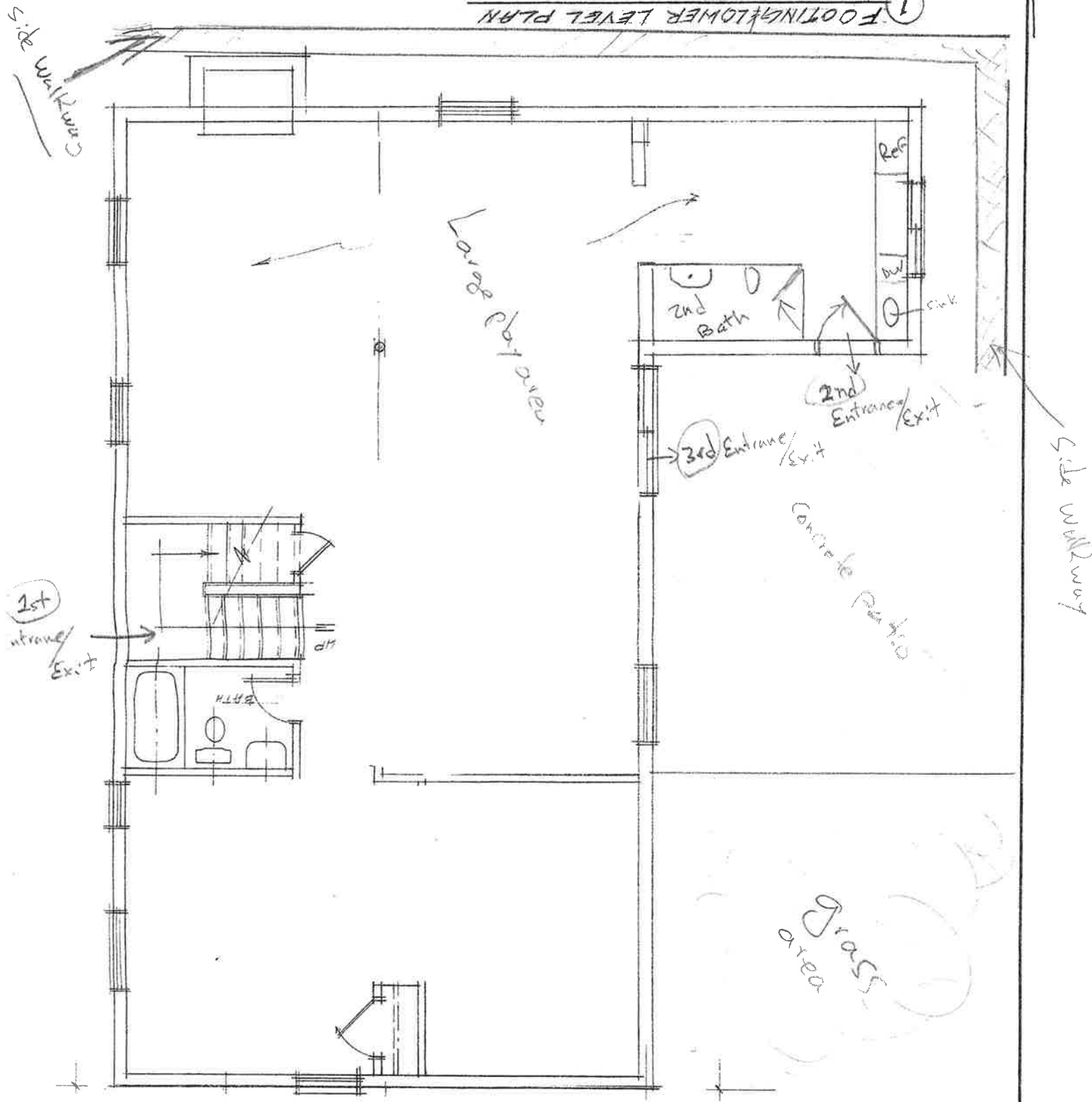

### **Traffic Calculation**

Our daycare is located in a cul-de-sac with the minimal traffic. The location is very safe for children drop-offs and pick-ups. Our daily drop-offs and pick-ups are staggered.

Morning drop-offs start from 7:30 and end at 8:30/8:50. Our customers park on our driveway and the front curb of our home and leave less than five minutes. Our pick-ups start from 4:30 to 5:50/5:55. To reduce the parking duration in our cul-de-sac, we make sure to have the child/children ready at the main entrance (inside) for the late pick-ups. We have also requested our customers to park at designated areas to express our gratitude to our neighbors.





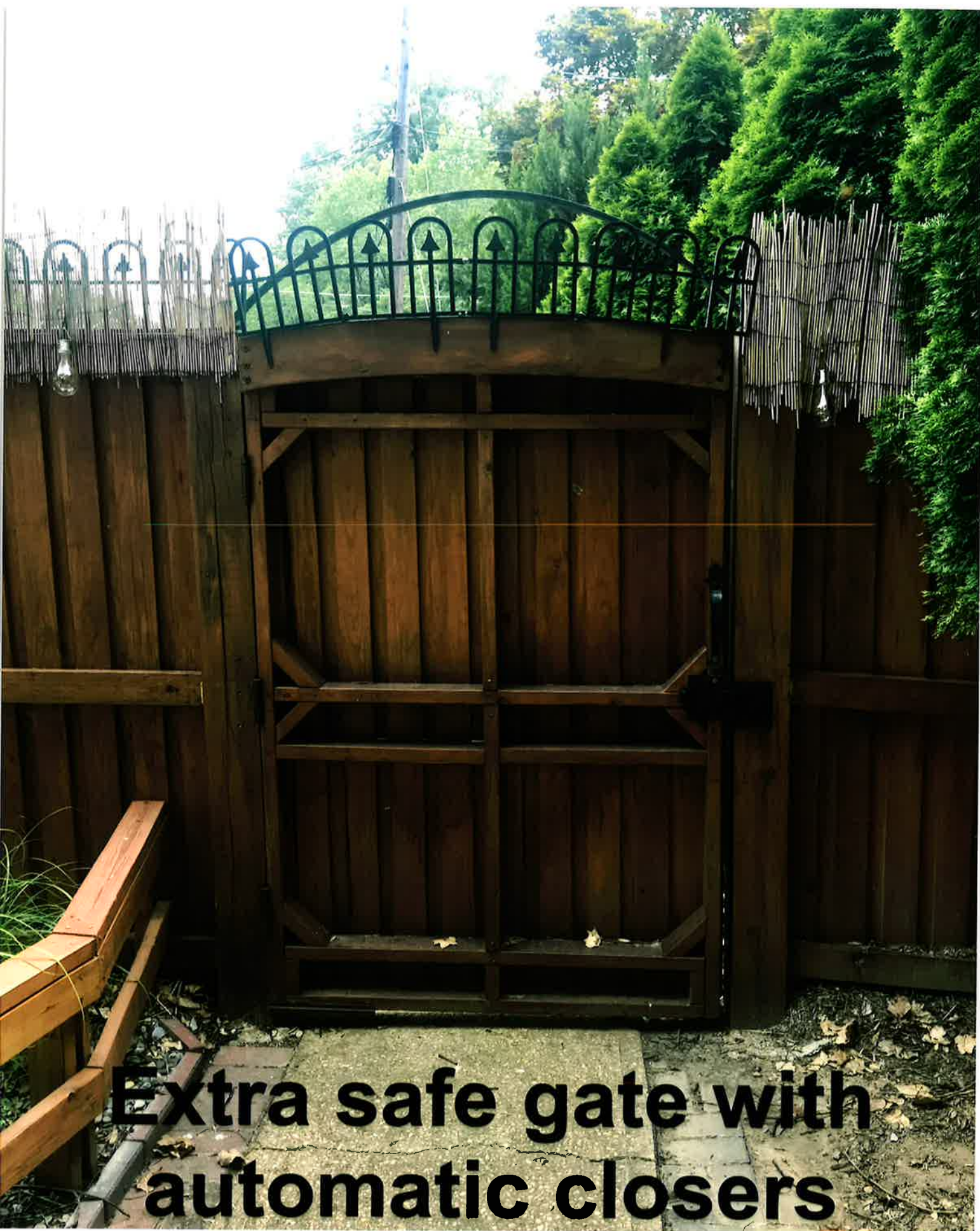

We highly recommend Happy Younglings.

Our oldest attended from about 14 months old to 3.5 years old and our youngest from 5 months old to 3 years old. We considered many childcare options from nannies to corporate centers to other in-home daycares and feel so blessed that we found Happy Younglings. We have been so impressed with how the owner, Tania, and her two assistants provide such a loving, kind, happy environment for the children in their care while also ensuring structure and appropriate play-based learning. The children eat healthy, delicious food (including breakfast, lunch, and snack) and play in a large playroom and outside in the home's enormous backyard. Inside, they play music, dance, do puzzles, paint, read books, play with trains, legos and other building tools, and engage in plenty of free play. Outside, they play on a playground appropriate for a wide age range, chase bubbles, play soccer, push toy lawn mowers, and study worms and leaves. The children learn all sorts of important social skills, including how to share and work out disagreements with their peers, politeness, gentleness with babies, following directions, and sitting with peers to eat.

Tania has a tremendous amount of experience to help with the various things that can be tricky with daycare. She works with parents to help breastfed babies accept bottles, to help kids nap on a schedule, to work through periods of separation anxiety, and to help kids learn toileting. She recognizes that kids develop at different paces and she is receptive to parent requests and feedback. She is organized and makes daycare as easy on the parents as possible by announcing holidays and vacation time at the beginning of the year, rarely closing for weather (even when local schools are closed), and providing daily written reports for each child. She often sends photos taken during the day, especially on days when a child cries at drop off. Although both of our children went through brief periods of separation anxiety, the vast majority of the time they bounced down the stairs, eager to see their friends, Tania, and her assistants. At times it was difficult to get them to leave! And even though they have now both left for preschool, they still love going back for visits. In short, Happy Younglings truly is a home-based, family-style setting in which the providers truly love the children and, as a result, the children flourish in their care.

Anyone need childcare soon? Our wonderful in-home daycare will have a spot opening at the end of the month because a full time preschool spot just opened for our 3.5 year old. My older son has been there since he was 14 mo and my younger son started at 5 months and will continue.

First, a bit of practical stuff: It is located near Cunningham Park, on a cul de sac near Kingsley, between Park and Cottage. It's open 7:30-5, later than many in-home daycares. There are 8 kids with one full time caregiver and two assistants (one in the morning and one in the afternoon).

We LOVE Happy Younglings. We had nannies for our son's first year and then visited a TON of daycares and read even more reviews and inspection reports before choosing Happy Younglings. It is exactly the environment we wanted -- warm, consistent, and home-like, with just the right amount of socialization for toddlers. In fact, it's been so perfect that the times when we've thought about moving, it is the idea of finding a comparable daycare that causes me to panic. It is warm, consistent, and home-like.

The kids spend a ton of time in the enormous backyard (it rivals many playgrounds!), dance to music, do art projects, and learn in the best way possible -- through play. The owner and lead caregiver, Tania, is a wonderful combination of loving, fun, and firm and her two assistants (one in the morning and one in the afternoon) are so warm and affectionate that my boys are almost always happy to go there and sad to leave. Our sons have both learned incredible manners there -- basic elements of politeness that I'm not sure we could have taught them at home without the group setting. My older son has made friendships that I hope will last a lifetime (as have his parents!) and I'm betting my younger son will as well.

Perhaps most importantly, I always feel confident leaving my boys in their care. As just one example of how careful they are with the children, my older son is allergic to peanuts and milk. Happy Younglings is nut free and also worked with us to make sure that in the 2+ years he was in their care our son never had a food allergy incident -- highly impressive given that he is allergic to something the other kids ate and drank daily. We are so grateful to Happy Younglings for the physical, emotional, and educational care they have given to both our boys during their time there.

Forgive the novel-like nature of this post. I remember how hard it was to pick a daycare, and can't help but give every bit of info I can think to share. Please feel free to PM me if you want to ask questions or chat by phone. We would love to help Tania find a new family to add to the group!
