Resolution for Continuity of Government

Mayor DiRocco opened the work session reading aloud the Resolution for Continuity of Government. Council approved via voice text.

2. Regular Business

Town Manager Payton made a statement to Council regarding the recent killing of George Floyd by Minneapolis police. He expressed his support for the Vienna police and the proposed police station project. The George Floyd killing was horrific, and the resulting public outrage understandable. However, he stressed that this is not the time to throw out law enforcement, but rather this is the time to make it better. He expressed concern regarding the growing sentiment toward defunding the police; an action that he believes would result in greater harm to the Black Community. He concluded stating we all want good law enforcement that is fairly and equally applied to all Americans.

Review progress of the Police Station project with Dewberry and Project Management Team

Members of the Downy and Scott project management team, Bill Downy and Kevin Fallin, along with Rod Williams, representing the architect firm of Dewberry Architecture, updated Council on the progress of the project.
