Subject: questions about potential sidewalk projects

Good morning -

Thank you for the opportunity to ask questions about the proposed sidewalk project along DeSale Street and Melody Lane.

We live at 122 Melody Lane SW, and our questions apply if the sidewalk is considered for our side of the street.

1. We have done a lot of landscaping including low rock walls around the gardens near the front of the property, and there is also a large crepe myrtle tree close to the property line as well. Whose financial responsibility would it be to relocate these features?
2. If sidewalks were installed on our side of the street, how would that impact the calculation for our lot-coverage requirements? (We have looked at the potential to add a covered screen porch, and were just over the calculated figures, but had been following Council action that might have slightly revised these calculations).
