Hello -

My name is Anne Ferguson and I live at 644 Tazewell Rd, just at the corner with Holmes. Due to a work commitment, I am not able to join tonight's open forum, but I did want to provide some feedback.

As a parent of elementary and middle school aged children, and an avid outdoor walker and runner, I am extremely concerned about the safety of our street. That said, I do not currently believe that a sidewalk is needed. Tazewell is extremely narrow and there are usually lots of cars parked on both sides of the street. Which means that, unlike John Marshall and Upham, Tazewell is rarely used as a cut-through between Center and Lawyers. Both the resident and non-resident cars on the street drive quite slowly due to the road being narrow and having lots of parked cars.

We also have a number of beautiful old trees on both sides of the road, which I assume would have to be sacrificed for a 5 foot wide sidewalk. These trees add so much to the beauty of the street and individual lots up and down the street. It would be a true shame to lose them.

I think it's wonderful that the Town has been given the gift of funding to build more badly needed sidewalks. I just feel there are many places in town that could more significantly benefit from a sidewalk than our street.

Due to the low traffic on the road, slow speed of any traffic, and loss of green space and trees a sidewalk would mean, I would not currently favor putting a sidewalk on either side of the street.

This situation is unnecessarily dangerous because of the narrowness of the street and the frequency of street parking on the block.
