DPW is requesting to waive competitive procurement for this item due to the time constraints with the Cares Act Funds expiring 12/30/20, however, three quotes were obtained. DPW is requesting to utilize Currie Heating and Cooling to install the GPS units on all HVAC units within all Town Buildings. The GPS (Global Plasma Solutions) air purification system fights pathogens, bacteria, mold, dust and airborne viruses. The GPS technology cleans the air by introducing ions into the space by the airflow through the ventilation system. Due to the Covid 19 Pandemic the GPS air purification system is essential to public health and safety as it will make the air quality in Town Buildings safer.
