We received your letter dated February 4, 2021 regarding the Public Meeting for a potential sidewalk project at Woodview Circle. There are 6 residences on Woodview Circle and all 6 strongly oppose a sidewalk on the circle. Our circle is a quiet and quaint circle with little to no traffic where the kids can bike and play in the circle without much concern for speeding cars. Additionally, Woodview Circle is not a street that people use for walking as there is no destination, only a "dead end". Adding sidewalks will cut deep into our front grass and landscaped areas and unnecessarily increase the impermeable areas leading to additional storm water run-off into our sewers, creeks, and rivers. The usage of these sidewalks will be nearly zero yet the cost, construction disturbance, environmental impact, and effect to our properties will be extraordinary.

It is not clear to use why Woodview Circle is under considerations for sidewalks but we believe this does not make sense for the Town and property owners. We unanimously oppose this project.
