Recently your street was identified for a potential sidewalk project as part of the Robinson Trust Sidewalk Program. They wanted to make sure that their comments were received and that the comments were going to be presented to Town Council. • 612 Blackstone Terr **Wendy Cardonz** Does not want sidewalk and is concerned about the impermeable surface and how much it will affect her front yard.

• 105 SE **Mr. Tyler Blanchard** – Is in support of sidewalk. Understands that the sidewalk is proposed for the other side of the street but would love for sidewalk to also be installed on his side of the street.

Charles Street SE – Branch to the end:

• 307 Charles Street SE **Todd & Laura Dunbar** – Todd vehemently disagrees with sidewalk on his side of the street. He does not care if it is installed on the other side of the street. Sidewalk will take up a good portion of his front yard. He does not feel that the sidewalk is necessary because no one walks on the cul de sac. He does not believe that there is right of way in front of his house because of an article he read. Three items requested: (1) a plat that indicates where his property line is (2) results of the survey done for Charles Street SE and (3) wants to make sure that Town Council hears his opinion even though he expressed his opinion on the survey. Oak Street SW - Birch Street to Center Street

- 107 Oak St SW Dale Griffiths Mr. Griffiths spearheaded a petition of his neighbors. The result 0 being in opposition to sidewalk on Oak Street. The petition result are significantly different from the survey information sent in. Mr. Griffiths is a retired federal government worker and knows how government works. He has lived in Vienna for over 30 years, knows all of his neighbors and says that this project has pitted neighbor against neighbor. He feels that the sidewalk is not necessary. He has an old tree in his front yard that provides shade to his front porch and has already been cut by Virginia Power and does not want the Town to cut the branch that hangs over the Town's right of way, cutting the branch will kill the tree. He is paying an arborist to keep the tree alive and is not interested in the opinion of the Town's arborist. Mr. Griffiths feels that this process is inadequate, that plans should have been sent provided to show where the sidewalk will go. He does not want the "speed hump/caution children at play" sign moved to be in front of his house. Feels that the "stop" sign at the corner of Oak and Cottage has caused an increase in traffic on Oak Street and wants to know if it can be removed. Mr. Griffiths feels that this process for proposing sidewalk on Oak Street should have stopped once he submitted the petition. He also feels that a different question should have been asked on the survey "do you support sidewalk on your side of the street". He does not agree with the town's number of addresses surveyed. Mr. Griffiths provided reasoning for installing sidewalk on the other side of the street but is not recommending sidewalk on the other side, the project should be cancelled. He feels that a zoom meeting should have been offered instead of the face to face meeting. He is immune compromised but was comfortable attending because of the small number people in attendance.
- 109 Oak St SW **David Degatis** is a lawyer. He lives with his wife and 7 year old daughter. His daughter and friends plays in the street and it is ok. Neither he, his wife nor daughter want the sidewalk project on Oak Street. Mr. Degatis feels that sidewalk on Cottage Street and Center Street are justified in having sidewalk because they are major streets. Oak Street is a side street

so sidewalk is not needed. He does not want his driveway to be removed and replaced. He also has planted landscaping in the Town's right of way. Mr. Degatis provided reasoning for installing sidewalk on the other side of the street but is not recommending sidewalk, just pointing out that it is possible. As a result of the petition results gathered by Dale Griffiths, Mr. Degatis feels that the sidewalk project on this street should not be built.
