Upon execution of this document, an award to <u>Town of Vienna</u>, Federal Identification Number (FEIN 54-6001654, <u>DUNS #</u> hereinafter referred to as "<u>Sub-recipient</u>" in the amount of <u>\$7,500.00</u>, is made under the authority of Cooperative Forestry Assistance Act of 1978, P.L. 95-313, as amended. 16 U.S.C. 2101 et. seq.

This award should promote, support and participate in the federal grant program, sponsored by <u>USDA</u>, <u>U.S. Forest Service</u>. The Federal Assistance Listing Number (ALN) (formerly Catalog of Federal Domestic Assistance-CFDA) and name are 10.664, Cooperative Forestry Assistance. Your application for federal assistance, dated <u>8/18/2021</u> and the attached provisions by the Virginia Department of Forestry are incorporated into this letter and made part of this award.

The Virginia Department of Forestry and <u>Sub-recipient</u> share the same goal of sustaining the health, diversity and productivity of the Nation and the Commonwealth's forest and grasslands.

Virginia Department of Forestry, referred to as VDOF, is a state government agency in the governor's cabinet by the Secretary of Agriculture and Forestry. As such:

- VDOF has an operational budget of approximately \$25 million and employs 240 salaried staff.
- Virginia has 26 state forests that include 71,972 acres (of which 96% are certified sustainable) and are managed for timber, recreation, water, research, wildlife habitat, and biodiversity protection.
- Forestry is the third leading economic engine in Virginia. The forest industry generates more than 108,000 related jobs and contributes \$21 billion annually to Virginia's economy.
- The state forests of Virginia are self-supporting and receive no taxpayer funds for operation. Operating funds are generated from the sale of forest products.
- Up to 25% of revenue received from forest products sales is returned to the counties where the forests are located.
- A. **Legal Authority**: <u>Sub-recipient</u> shall have the legal authority to enter into this award and the institutional, managerial, and financial capability to ensure proper planning, management and completion of the project, which includes funds sufficient to pay the nonfederal share of project costs, when applicable.

Attachment A: Virginia Department of Forestry Award Provisions

- A. **Collaborative Arrangements:** Where permitted by terms of the award, <u>Sub-recipient</u> may enter into collaborative arrangements with other organizations to jointly carry out activities with grant funds.
- B. **Non-Liability:** The Virginia Department of Forestry does not assume liability for any third party damages arising out of this award.
- C. **Notices:** Any notice given by the U.S. Forest Service or Virginia Department of Forestry will sufficient only if in writing and delivered in person, mailed, or transmitted electronically by e-mail or fax, as follows: The Virginia Department of Forestry, at Virginia Department of Forestry's address shown in the grant or such other address designated within the grant. Notices will be effective when delivered in accordance with this provision or on the effective date of the notice, whichever is later.
- D. Federal Cost and Administrative Regulations:
 - This is an award of Federal financial assistance. Prime and sub-recipients to this award are subject to the OMB guidance in subparts A through F of 2 CFR Part 200 as adopted and supplemented by the USDA in 2 CFR Part 400. Adoption by USDA of the OMB guidance in 2 CFR 400 gives regulatory effect to the OMB guidance in 2 CFR 200 where full text may be found. - E. - F. I. Drug- Free Workplace:

- 1. <u>Sub-recipient</u> agree(s) that it will publish a drug-free workplace statement and provide a copy of any project/program that receives federal funding. The statement must:

- 3. Without the Virginia Department's expressed written approval, the policy statement and program must be in place as soon as possible, no later than 30 days after the effective date of this award, or completion date of this award, whichever occurs first.
- 4. <u>Sub-recipient</u> agree(s) to immediately notify the Virginia Department of Forestry if an employee is convicted of a drug violation in the workplace. The notification must be in writing, identify the employee's position title, the award number of each award on which the employee worked. The notification must be sent to the Virginia Department of Forestry within ten calendar days after <u>Sub-recipient</u> learn(s) of the conviction.
- 5. Within 30 calendar days of learning about an employee's conviction, <u>Sub-recipient</u> must either, take appropriate personnel action against the employee, up to and including termination, consistent with the requirements of the Rehabilitation Act of 1973 (29 USC 794) as amended or require the employee to participate satisfactorily in a drug assistance or rehabilitation program approved for these purposes by Federal, State or Local health, law enforcement, or other appropriate agency.
- J. **Eligible Workers:** <u>Sub-recipient</u> shall ensure that all employees complete the I-9 form to certify that they are eligible for lawful employment under the Immigration and Nationality Act (8 U.C.S. 1324a). <u>Sub-recipient</u> shall comply with regulations regarding certification and retention of the completed forms. These requirements also apply to any contract or supplemental instruments awarded under this award.
- K. Advance/Reimbursable Payments: Only costs for those project activities approved in (1) the initial award, or (2) modifications thereto, are allowable. Requests for advance and/or reimbursement of eligible grant expenditures is based on the availability of funds awarded or appropriated for that purpose. Payment requests should be submitted to Program Managers for review to ensure requests are in compliance with all programmatic and administrative policies and procedures. If <u>Sub-recipient</u> receive(s) an advance payment and subsequently request(s) an advance or reimbursement payment, then the request must clearly demonstrate that the previously advanced funds have been fully expended before the Virginia Department of Forestry can approve the request for payment. Any funds, advanced, but not spent, upon expiration of this award shall be returned to the Virginia Department of Forestry.
- L. **Award Closeout:** Award will be closed out either on the expiration date or with the notice of termination. Any unobligated funding at that time will be reverted to the Department of Forestry.
- M. **Program Performance Reports:** <u>Sub-recipient</u> shall monitor the performance of the grant activities to ensure that performance goals are being achieved. Performance Reports will include: A comparison of actual accomplishments to the goals achieved for the period; reason(s) for delay if established goals were not met; additional pertinent information pertaining to the grant. Performance Reports shall be submitted to the Program Manager(s) <u>Lara Johnson</u>.
- N. **Notification:** Sub-recipient should immediately notify the Virginia Department of Forestry of developments that have a significant impact on the activities supported under this grant. Also, notification shall be given in the case of problems, delays or adverse conditions that materially impair the ability to meet the objectives of the award. This notification shall include a statement of the action taken or contemplated, and any assistance needed to resolve the situation.
- O. Changes in Key Positions and Personnel: Any revisions to key positions and personnel identified in the application for this award require prior, written approval from the Department of Forestry. Failure to obtain prior, written approval when required may result in the disallowance of costs.

- P. **Freedom of Information Act (FOIA):** Public access to grant or agreement records shall not be limited, except when such records must be kept confidential and would have exempted from disclosure pursuant to "Freedom of Information" regulations (5 U.S.C. 552).

It is encouraged to give public notice of the receipt of this award from time to time, to announce progress and accomplishments. Acknowledge the U.S. Forest Service as well as the Virginia Department of Forestry support in publications, audiovisuals and electronic media developed as a result of this award. A mandatory provision if development of publications or production of audiovisuals, or if information is shared via electronic format (including websites).
- S. Acknowledgment in Publications, Audiovisuals and Electronic Media: <u>Sub-recipient</u> shall acknowledge the Virginia Department of Forestry and U.S. Forest Service's support in any publications, audiovisuals, and electronic media developed as a result of this award.
- T. **Nondiscrimination Statement-Printed, Electronic or Audiovisual Materials**: <u>Sub-recipient</u> shall include the following statement, in full, in any printed audiovisual material or electronic media for public distribution developed or printed with any federal funding.

- U. Termination by Mutual Agreement: This award may be terminated, in whole or part, as follows: when <u>Subrecipient</u> and the Virginia Department of Forestry agree upon termination conditions, By 30 days written notification from the Virginia Department of Forestry and in the case of partial termination when the U.S. Forest Service determines that the remaining portion of the award will not accomplish the purposes for which the award was made, the U.S. Forest may terminate the award at its entirety.
 Upon termination of an award, <u>Sub-recipient</u> shall not incur any new obligations for the terminated portion of the award after the effective date, and shall cancel as many outstanding obligations as possible. The Virginia Department of Forestry shall allow full credit to <u>Sub-recipient</u> for the United States Federal share of the non-cancelable obligations properly incurred by Sub-recipient on the effective date of termination.
- V. **Disputes**: Any disputes under this award shall be decided by the Program Manager. The Program Manager shall furnish <u>Sub-recipient</u> a written copy of the decision. Decisions of the Program Manager shall be final unless, within 30 days of receipt of the decision of the Program Manager, <u>Sub-recipient</u> appeal(s) the decision to the Virginia Department of Forestry. Any appeal made under this provision shall be in writing. In order to facilitate review, <u>Sub-recipient</u> shall be given an opportunity to submit written evidence in support of its appeal. No hearing will be provided.
- W. **Debarment and Suspension:** <u>Sub-recipient</u> shall immediately inform the Virginia Department of Forestry if they or any of their principals are presently excluded, debarred, or suspended from entering into covered transactions with the federal government according to the terms of 2CFR Part180. Additionally, should <u>Sub-recipient</u> or any of their principals receive a transmittal letter or other official federal notice of debarment or

- suspension, then they shall notify the Virginia Department of Forestry without undue delay. This applies, whether the exclusion, debarment or suspension is voluntary or involuntary.

The U.S. Forest Service reserves a royalty-free, nonexclusive, and irrevocable right to reproduce, publish or otherwise use and to authorize others to use the work for federal government purposes. This right shall be transferred to any sub-awards, sub-agreements or sub-contracts. This provision includes: The copyright in any work developed by Virginia Department of Forestry under this award and any rights to copyright which Virginia Department of Forestry purchase(s) ownership with federal contributions.
- Z. **Program Income:** If any program income is generated as a result of this award, it must be deducted from the gross expenditures that are being charged to the award in accordance with the applicable Cost Principles.
