4. Reports/Presentations

A. Report and Inquiries of Council Members

Councilmember Springsteen reported that on Sunday the 11th Annual Turkey Trot will be held. Councilmember Springsteen thanked the Parks & Recreation Director and the Public Works Director for helping with a couple issues that the people running the race were concerned about.

Councilmember Springsteen reported that he is happy to see that some of the projects are getting done before the cold weather sets in.

Councilmember Kelleher reported that the new paving on Moore Avenue looks very nice.

Councilmember Kelleher stated that she received an email from VML announcing that there will be several members of the General Assembly that will be coming to the Local Northern Virginia Breakfast on November 30th and she is the only one that has signed up to come. She encourages other Council Members to attend.

Councilmember Sienicki wished everyone a wonderful Thanksgiving and she is thankful to be able to serve with the Mayor and all the Council Members, the Town Manager, Town Clerk and Town Attorney and all the staff. She also thanked all the citizens who make it such a wonderful place to be.

Councilmember Sienicki thanked the American Legion for the flags that they put up and down for Veterans Day and for the memorials that they put at Flint Hill Cemetery, they do a great job and they had a wonderful presentation for Veterans Day. She thanked them for their dedication to those that have served.

Councilmember Sienicki invited everyone to shop on Saturday after Thanksgiving to support the local businesses in Vienna.

B. Report of the Town Manager

Mr. Payton reported that in lieu of their recent attacks in Paris and some information that has been heard about the Washington DC Metro area, he wanted to let Council and the citizens know that Chief Morris and himself along with the Emergency Management Team are monitoring things as they would in any situation. There is nothing specific that is out there that they are aware of but at the same time they do have their quarterly emergency management discussions and meetings as well as keep in touch with their regional partners.

C. Report of the Mayor

Mayor DiRocco reported that on Wednesday, November 4th she went to Thoreau Middle School and talked to about 440 7th graders about the Virginia Municipal Leagues "If I were Mayor" essay contest. The essay contest is open to all 7th graders in Virginia. She talked to students about the role of Mayor and Council as well as what local government does. She is hopeful that they get some students from Thoreau to apply since it would be great recognition as well as there are monetary rewards.

Mayor DiRocco reported that on Wednesday, November 10th, at the Mayor's at Your Service, she had the Virginia Department of Transportation come in and present their preferred alternative for the I-66 Expansion. The Town remains concerned about the impact on Marshall Road Elementary School, Yeonas Park and the nearby residents. As new information becomes available the Town will invite VDOT back to Town Hall to help address those issues.

Mayor DiRocco also reported that on Friday, November 13th her walking group headed over to Marshall Road Elementary to join their Runathon where the students from all grades go around the track. They walked around the track with 2nd, 3rd and 4th grader's for a few laps. Police Chief Morris and Deputy Chief Janickey also appeared and they were the highlight of the walk. The students really appreciated having them there and she knows the Marshall Road Community appreciated it.

5. Public Hearings

A. Public Hearing for Green Bond Issuance for CIP.

Mayor DiRocco called the Public Hearing to order at 8:37 p.m. The Town Clerk called the role and all members of Council were present.

Ms. Karen Spence, Finance Director explained that she has requested the Public Hearing for the Town's Bond issuance on Green Bonds and is in accordance with the Council approved Capital Improvement Plan, which is the fiscal year 2016 bond issuance. 86% of this bond will be for the funding of the second and final phase of the Community Center renovation and construction. The remainder will fund

stormwater and water & sewer improvement. Funding of the projects is projected at 6.75 million dollars and does include the monies for the issuance cost. They did their research on the suggested Virginia saves program. A cost benefit analysis was completed by Davenport with the town's input. It was determined that the benefits were out weighed by the cost on that so it is not the best option for us at this point in time. One of the special items about the bond is that it is a "green" designation and they are very excited about that. This will allow for a potentially bigger and wider audience for selling our bond. As for the required publications, they have done two publications in the newspaper as well as this Public Hearing to allow for input by Town residents.

It was moved to close the public hearing at 8:40p.m.

It was further moved that the Town Clerk and Bond Counsel be authorized to advertise notice of the adoption of such bond ordinance.

Number 5 he left in with a note stating that the Town intends to gather statistics, he didn't know what the Council's mind was on that but should let their Legislators know it is on their radar but were not requesting specific legislation this year. Mayor DiRocco stated that she likes that it is on there as a reminder as well as saying they are going to gather statistics so they are well aware. Mr. Briglia stated that he believes he has caught all the ones they wanted to keep and took off that were going to be deferred for future years.
