*The Planning Commission met in regular session on Wednesday, May 12, 2021 at 7:30 PM with Stephen Kenney, Chairman presiding. Adoption of the Continuity of Government allowed the following to participate electronically: David Miller, Andrew Meren, Julie Hays, Sarah Couchman, David Patariu, Sharon Baum, Jessica Plowgian, and Keith Aimone.*

*Chairman Kenney read into the record the Continuity of Government.*

#### 2. Recommendation to the Board of Zoning Appeals for a conditional use permit to establish an animal hospital at a commercial tenant space located at 124 Park Street, SE Unit 100, in the C-1 Local Commercial zone.

*Chairman Kenney called on Frank Simeck, Zoning Administrator to present the Item for consideration. Also present to answer questions from the Commission were Rory Caracciolo, CEO, Veterinary Surgical Centers Rehabilitation; Dr. Anke Langenbach, Owner and Medical Director, Veterinary Surgical Centers Rehabilitation; Sergio Sur, Princeton Design. Providing staff's report, Mr. Simeck provided a breakdown of the building's current tenant layout in comparison to parking tabulations and hours of operation, which are Monday – Saturday, 7 am to 6 pm and closed on Sunday.*

*Concluding Mr. Simeck's presentation, commissioner discussion included location*

*of pet waste stations with clarification that the business will operate on two levels in the building with a total of twelve employees in the new section and current employees remaining.*

*Sergio Sur, Architect with Princeton Design provided a brief description of the proposed layout, which included the use of foam acoustic insulation and ceiling tiles to assist with any noise mitigation concerns.*

*No members of the public were present to speak to the application. There being no further questions or comments, Chairman Kenney called for a motion.*

*Commissioner Miller made a motion that recommendation for approval be made to the Board of Zoning Appeals for a conditional use permit with the restrictions aforementioned in the Staff Report to establish an animal hospital at a commercial tenant space located at 124 Park Street, SE Unit 100, described as tax map parcel 0382 58 0100.*

*Having reviewed several similar businesses at this location, Commissioner Miller stated that it is a business model that works. Steps in noise attenuation works. Animals in public spaces has not been an issue and there is a need for this type of business.*
