- *Propose adding two goals: continuous public engagement to assure meeting of community recreational needs; increase partnerships with county, schools, NOVA parks local businesses to further expand Parks and Recreational opportunities.*

- *Consider adding goals related to increasing open space, increasing awareness of activities and resources; encouraging use of solar;*
