Group 2 discussion included next steps review process for the Comprehensive Plan. Staff suggested scheduling a full Planning Commission work sessions to review each chapter's draft language. Commissioner Aimone will reach out to the Conservation and Sustainability Commission (CSC) Chair for feedback and suggestions on energy costs relating to greenhouse gas documents. To date Group 2 has received feedback from Transportation Safety Commission (TSC) and the Pedestrian Advisory Commissions (PAC). The subcommittee briefly discussed glass recycling and asked Mr. Sergent to follow up with Department of Public Works staff on the Mill Street NE glass recycling facility. Further discussion included whether tree canopy requirement changes have come out of Richmond. Subcommittee members will provide draft edits to Commissioner Kenney who will incorporate them into the group's share document.
