Comprehensive Plan Subcommittee Work Session - Environment & Sustainability and Parks & Recreation

The Planning Commission Comprehensive Plan Subcommittee on Environment & Sustainability and Parks & Recreation (Group 3) met for a work session on Wednesday, October 13, 2021, at 8:30 PM in the Council Chambers of the Vienna Town Hall, 127 Center Street South, Vienna, Virginia. Adoption of the Continuity of Government allowed the following Subcommittee members to participate electronically: Jessica Plowgian and David Miller participated via Zoom.

Participating staff included: Cindy Petkac, Director of Planning & Zoning and John Sergeant, Town Engineer with the Department of Public Works both present via Zoom. Jennifer Murphy, Clerk to the Commission was present at Town Hall.

Group 3 - Environment & Sustainability and Parks & Recreation Discussion

Group 3 reviewed and discussed draft language edits. Staff advised that the Park Master Plan will include the purchased town owned property. A Town Council conference session has been scheduled for November 8, 2021, to discuss the newly acquired properties: Faith Baptist Church, Beulah Roadhouse, and the Robinson house. Review of the Park Master Plan is scheduled for November 15, 2021.

Further subcommittee discussion included recycling, composting language and whether revised language for sustainability has come out of Richmond. Within five years staff anticipates state language for storm water management and E&S (Erosion and Sediment) requirements; both are currently under study. There being no further edits Commissioner Plowgian will notify Chairman Kenney that Group 3 is ready to move draft comprehensive plan language for Chapters 7 & 8 forward for full Planning Commission review.
