**Subject:**

The Vienna Police Department requests approval to ride Virginia state contract E194-77910 to purchase new in-car radar units for all patrol vehicles (11) and new Lidar handheld ProLaser units (10) from Kustom Signal, Inc., for a cost not to exceed \$51,202.

**EXPLANATION AND SUMMARY :**

In October 2019, the Town was awarded \$51,000 through a grant from the Virginia Department of Criminal Justice Services for purchase of new in-car and handheld speed enforcement equipment. This is a reimbursement grant so the purchase will take place for the amount of \$51,202, and the Town will be reimbursed \$51,000. The difference will be funded from federal seized asset funds.
