Adoption of a proposed ordinance to re-number the Code of the Town of Vienna, Chapter 18, Zoning, Article 14, CMP Industrial Park Regulations, Section 18-95.1 Applicability and Purpose.

EXPLANATION AND SUMMARY :

The adoption of the Maple Avenue Commercial (MAC) zone requires renumbering a subsequent code section to allow for numerical continuity and to provide for reserved sections for future code additions, if necessary. Per **§ 15.2-1433. Codification and Recodification of Ordinances** of the Code of Virginia, *"Renumbering or rearranging of sections, articles or other divisions of any such ordinance shall not be deemed to be a change, alteration or amendment of a substantive nature."* The proposed renumbering does not alter any code provisions.
