EXPLANATION AND SUMMARY :

To keep the Vienna Community Center renovation and expansion project on the critical path of construction, Keller Brothers and RRMM/Lukmire Architects have agreed to increase their scope of work to upgrade the elevator and install theatrical lighting, audio, and curtains in the auditorium. The \$310,000 requested in expenditures will be allocated as follows:

The following proposed expenditures will be used to increase the Keller Brothers contract.

- \$137,104 Upgrade the elevator
- \$143,881 Install theatrical lighting, audio, and curtains

The following proposed expenditures will be used to increase RRMM Lukmire Architect's contract.

- \$22,896 Design work to upgrade the elevator
- \$ 6,119 Design work to install theatrical lighting, audio, and curtains

Departmental Recommendation :
