Public Hearing on FY 2018-19 Proposed Budget

EXPLANATION AND SUMMARY:

The Town Manager's Proposed Budget for Fiscal Year 2018-19 has been presented to the Mayor, Town Council, and residents. The proposed budget has been reviewed by Town Council during work sessions on March 17 and 19. A final work session will be held April 16, 2018 to discuss funding current unmet needs. This public hearing is held so that Town of Vienna residents may provide public input.

The Proposed Fiscal Year 2018-19 Town of Vienna Budget totals \$38,542,470 for the fiscal year beginning July 1, 2018 and ending June 30, 2019, and is broken down as follows:

- * \$25,353,990 for General Fund expenditures
- * \$4,223,290 for Debt Service Fund expenditures
- * \$8,601,190 for Water and Sewer Fund expenditures
- * \$364,000 for Stormwater Fund expenditures

The proposed budget is based upon a real estate tax rate of \$0.2250 per \$100 valuation; bank net capital at \$0.80 per \$100 valuation, and utility tax for residential uses at a rate of 20% of the first \$15 and for commercial uses at a rate of 15% of the first \$300.
