**EXPLANATION AND SUMMARY :**

The Community Enhancement Commission (CEC) brought Solarize NOVA, a solar purchasing program, to residents and businesses of Vienna during the springs of 2015-18. The CEC would like to once again offer Solarize NOVA in spring 2019. Council adopted the original Solarize NOVA resolution on February 23, 2015. Solarize NOVA is an initiative of the Northern Virginia Regional Commission (NVRC) and the nonprofit Local Energy Alliance Program (LEAP). Solarize NOVA is a one-stop shop for residents to learn more about solar power options for their homes and businesses and helps facilitate installation and financing of these private projects.

Benefits of program include:

- free solar site assessments
- lower-than-ever solar panel pricing and affordable financing
- qualified local solar installers and high-performance systems
- free home energy inspections - to make your solar power go further
- free installed measures save an average of 759 kWh
- community workshops and support
- a great investment in clean energy
