Council Acceptance of American Recovery Plan (ARPA) Funds

EXPLANATION AND SUMMARY :

On March 11, 2021, the U.S. Congress passed the American Rescue Plan Act (ARPA), authorizing “relief funds to support State, local and Tribal governments in responding to the impact of COVID-19 and in their efforts to contain COVID-19 on their communities, residents, and businesses” (Interim Final Rule, U.S. Treasury Department, 5/24/2021).

On June 9, 2021 the Town received confirmation from Virginia’s Secretary of Finance that Vienna would receive \$17.1 million in Federal American Rescue Plan (ARPA) dollars distributed by the State. The Town will receive ARPA funds through the State as it is classified as a Non-Entitlement Unit (NEU), by virtue of size (population under 50,000) and organization - the Town does not receive federal housing block grants. These are indicators established by the federal legislation.

The funds will be distributed by the State in two equal installments. The first one is to be distributed by June 28, 2021 and the second a year after the first installment.

The Town was required to certify conditions laid out in the letter from Virginia Secretary of Finance (attached) and attest that the award was not in excess of 75% of the Town’s annual budget.

We ask Council to accept the first installment of ARPA funds in the amount of \$8,551,731.
