Approval to Publish a list of Delinquent Real Estate Tax Payments as of June 30, 2022 **EXPLANATION AND SUMMARY** :

Pursuant to sections 58.1-3921 and 58.1-3924 of the Code of Virginia, a certified list of delinquent real estate property taxes as of June 30, 2022 has been provided to the Town Council. Also included are a report showing changes in delinquent balances since June 30, 2022 and a list of annual taxes of less than \$5 each, totaling \$44.22, which will be written off with Council's approval.

At the end of FY 2022, 10 properties owed delinquent taxes totaling \$43,818, a decrease of \$22,126 from the previous year, due to continued payment of older past due bills. In FY 2022, 99.9% of real estate taxes were collected. The Town routinely collects more than 99% of delinquent taxes every year.

The delinquent real estate tax list was certified by the Town Clerk as required by State Code. The list of delinquent properties will be updated as of the Aug. 29, 2022 Council meeting to take into account payments made between June 30 and August 29. With Council's approval, a list of delinquent properties, their owners, and balances due as of Aug. 29, 2022 will be published in a local newspaper and posted on the Town's website. County records will be updated with delinquent balances added to existing liens; new liens will be placed on properties that have been delinquent for two years or more.
