Award a Design Contract to Whitman, Requardt & Associates, LLP, for Moore Avenue SE Drainage Improvements. **Approved in 2022 CIP**

EXPLANATION AND SUMMARY :

Moore Avenue SE has significant drainage issues between Marjorie Lane SE and Park Street. This project mitigates these issues by designing approximately 310 linear feet of concrete curb, gutter and sidewalk along the west side of Moore Avenue SE and approximately 40 feet of storm sewer pipe and additional curb inlets.

The Department of Public Works requests approval to use Whitman, Requardt & Associates, LLP to provide engineering services for the survey and project design utilizing the on-call contract RFP 19-01 in the amount of \$66,748.52, which includes contingencies for easement plats and utility test holes totaling \$9,390.94.
